❖ Curricular Aspects:

1. We have introduced PG courses in Bengali, Under West Bengal State University since 2008.
2. College has introduced semester system examinations with 50 marks in each module in PG course.
3. Honours course in Education has been introduced since 2011.
4. At present, the college runs 17 UG programmes, 1 PG programme and 3 Distance education programmes.
5. Academic flexibility is offered by the college by offering about 38 combinations in Arts stream, 10 combinations in Science stream and 1 combination in Commerce stream.
6. College is providing horizontal support through introduction of different programs suggested and funded by UGC like NET coaching class, Entry in Service.
7. Syllabus of PG course has been revised and updated from time to time keeping in view the modifications in the undergraduate syllabus.
8. A good number of teachers are members of Board of Studies (UG) of the parent University.
9. Feedback is taken from the 3rd year students regarding the curriculum and course offered. They are asked to give a point based feedback which is by the departments for future.



❖ Teaching ,Learning and Evaluation:

1. Teaching and Learning is given the utmost preference in this Institution.
2. The admission process is transparent. After the declaration of the Higher Secondary Results and keeping in view the order of the State Government, the important dates for admission process are publicized. The college website contains the latest information on admission process. The merit list, dates of counseling are posted on the college website.
3. The notice for PG admission is published in the college website and all subsequent dates mentioned.
4. Gender Balance: The number of female students admitted to the college during 2014-15 is 1157 as compared to 1325 in 2013-14. The ratio of the number of girls to boys is 719: 1000.
5. Number of students belonging to economically backward classes, who have been admitted to the college is 1655.
6. The reservation policies are strictly maintained during admission. The total number of students admitted to various undergraduate programmes is 2765 out of which 1099 belong to SC category, 23 belong to ST Category, 185 OBC A and 514 to OBC B categories.
7. The reservation for PH students is observed, a ramp for the physically disabled students has been constructed.



8. Regular monitoring of attendance of the staff members and students is done. For looking into the academic matters of the college, a senior teacher is delegated who keeps track of the classes, exam dates for the internal assessment, drawing of routines etc. Teachers update their appraisal reports and get it duly verified and signed by the authority.
9. In addition to 35 full time and 10 part time teachers of the college, 2 full time librarians; 11 teachers are employed on contractual basis so that regular classes in all the courses are held and to maintain a healthy teacher student ratio. Also a Librarian has been employed on casual basis for smooth functioning of the Library. For PG course in Bengali, Guest Lecturers visit the college regularly and teach specific modules.
10. Number of teachers holding Ph D degree is 20, holding M.Phil degree is 10, 7 teachers are pursuing research for Ph D dissertation , 18 teachers are NET and 6teachers are SET qualified.
11. The college has 40 computers in various departments ,all departments are equipped with internet connection, a smart board and two classrooms for ICT based teaching. Also PA systems for 7 Lecture halls have been set up.



12. The college library has acquired and installed SOUL 2.0 from the INFLIBNET Centre. To provide e-resources to students, researchers and other faculty members, the college has subscribed for the NLIST programme. Online access to 90000+ebooks and 6000+ full texts e-journals and periodicals can be made.
13. The number of non-teaching staff has been increased for support services.
14. The number of students who appeared in the final year examinations at the UG level in 2014 under WBSU is 1924, out of which 1683 passed. The number of students who appeared for MA Bengali in 2014 is 30 out of which 30(First Class 27) passed.
15. The college organizes regular evaluation through test examination. The students having practical based subjects are assessed on a regular basis.
16. Following stipends are provided to the economically backward students:
 - i) SC/ST/OBC Stipend (by SC/ST/OBC welfare department)
 - ii) Handicapped stipend (by Mass Education Centre)
 - iii) Bidi-Shramik Stipend
 - iv) Fishermen Co operative stipend

❖ Research, Consultancy and Extension

- 1) The college promotes increasing involvement of faculties in various kinds of research activities which could culminate into quality publications, extension of different new prospects and academic linkages.
- 2) The college encourage teachers to apply for grants, participate in collaborative and research based extension programmes, participate in national and international conferences organised by the college and other institutions.



- 3) The college teachers organize state and national level conferences and seminars in collaboration with other institutions.
- 4) Access to e-journals and e-books has been made through N-list INFLIBNET. A rich research friendly library resource of about **6000 e-journals and more than 90000 e-books** through **N-List** has been made available for the students and the faculties.
- 5) To promote and ensure smooth progress/implementation of higher research, a number of measures are usually adopted by the college.
- 6) Principal Investigators of the research projects are provided adequate autonomy in conducting the research work.
- 7) To promote and ensure smooth progress/implementation of higher research, a number of measures are usually adopted by the college.
- 8) Principal Investigators of the research projects are provided adequate autonomy in conducting the research work.
- 9) the faculty members of this institution have published 53 research papers (since 2004) in International journals, 37 in National level journals and 29 papers in state level journals.



- 10) Our faculties have received 16 Minor Research Projects from the University Grants Commission (UGC) since 2004 and most of have been successfully completed and some of those are ongoing projects, These research works have resulted in a number of publications, academic discussions and PhD awards

❖ **Infrastructure and Learning resources**

1.The college governance makes sufficient budgetary allocation for construction of new laboratories, upgradation of the existing laboratories and classrooms.

2.The total built up area of the college has increased from 2346.80 m² to 4508.15 m².

3.The college has an auditorium with a seating capacity of 250, a Seminar Hall equipped with a Smart Board, two digital classrooms, a garden with medicinal plants and plants of biological importance, a computer laboratory and well equipped laboratories compatible with the syllabus.

4.The college utilizes the grants received from UGC, State Government grants efficiently for purchase, maintenance and upgradation of the Departments. Funds are utilized for Library



upgradation, purchase of books for central as well as departmental libraries.

5.Coaching to post graduate students for appearing in NET Examinations is provided. Remedial Coaching is provided to SC/ST students of all departments to assist them in areas where they need attention. A library meant exclusively for Remedial Coaching, has been set up.

6.Awards are given to students excelling in various examinations to encourage them to achieve higher goals.

7. Students are provided with training for Entry in Services. A Gymnasium has been set up in the college premises.

8. The students are encouraged to participate in Sports at various levels aiming at overall development of students. Students participate in Quiz Contests, Mock Parliament programmes. The achievements shall be presented in the detailed report.

9. The computers are regularly updated with latest software.

10.The college has two NSS Units which organizes various Social Awareness programmes.



11.NCC is one of the remarkable wings of the Institution having 2 companies.

12.Internet connectivity in all the Departments, Library and Office is available.

13.The library is regularly updated through purchase of books, magazines and journals. The library is automated with access to 9000+e-books , 6000+ journals. Presently the library has 16381 books in various subjects.

14.The college has grievance redressal cell and a Women's cell for maintaining a healthy working atmosphere for staff members and learning atmosphere for students.

15.The college has a functional RTI Cell for dissemination of information to all concerned.

16.There is a staff co operative society which provides financial assistance to staff members, sanctions loans at short notices to the members in case of emergency. The maximum limit of emergency loan being Rs 80,000/-.



17. There is a Ladies' Hostel in the college premises, which has a capacity of boarding 100 members and has been constructed using UGC Grant during XIth plan.

18. The college has a Boys' Hostel with a capacity of 100 seats and a Women's Hostel for SC/ST constructed by Government of West Bengal, BCW Department.

19. The college premises is under CCTV surveillance. There is a 45 kV green generator for 24 hours power back up, a solar panel for solar power generation. (Financial grant from UGC under various schemes). 5 water purifiers and 4 refrigerators have been purchased for providing pure and cold drinking water.

20. All the departments are provided with a departmental office for faculty members and staff, internet connection and a library.

21. A laboratory for Computer Science Department has been set up. Also the Zoology laboratory has been renovated and extended keeping in view the latest syllabus. The extension of Botany Department with financial aid from the State Government is proposed.

22. For Bengali Department, there is an additional office and library for the PG course.



23. There is one smart classroom and two halls for ICT based teaching.

24. In addition there are study centres for Netaji Subhas Open University, Rabindra Bharati University and Kalyani University for distance learning.

25. The college also has a childcare unit so as to enable working mothers to bring their child along in case situation arises. There is a guest room in the college which is used by staff members and guests as per need.

26. A one time scholarship to BPL category students of 3rd year on the basis of the results is provided under UGC program. A conveyance allowance to promote regular attendance is also provided with UGC funding.

❖ Student Support and Progression

1. There is a widespread publicity of admission notice on the college website, notice board, local cable network. The eligibility criteria, merit list and all important dates are announced.



2. Students attendance is strictly maintained and guardians of the irregular students are informed. The Head of the Department meets the guardians for remedial measures.

3. In addition to the posts sanctioned by the Government, the college employs Guest Lecturers, Contractual Teachers to maintain good teacher student ratio.

4. Financial assistance to eligible students under various schemes of the State and Central Government is provided. In addition, stipends for SC candidates, ST candidates, Bidi Shramik candidates are provided. Under the "Kanyashri Prakalpa" of the State Government, female candidates attaining the age of 18 years are provided one time assistance.

5. Remedial coaching for economically backward students and the students belonging to SC,ST classes is provided. In addition to this, coaching for competitive exams for entry in services is provided. The college gymnasium provides opportunity for the students to access modern gadgets for body shaping, thus aiming at mental as well as physical development of the students.

6. The number of students appearing for the final year examination in 2014 is 1924. and the number of successful candidates is 1683.



7.The percentage of girl students is 41.8% for the academic session 2014-15 as compared to 42.2% in 2013-14.

8.Different welfare programmes are organized for the students, health camps for assessing the physical condition, diagnose serious ailments ,if any. Seminars on sexually transmitted diseases, blood donation camps and on current topics are organized. Popular level lectures are delivered by eminent speakers as well as by the teachers of the Institution.

9.Recently, History Club has been set up which organizes monthly seminars on diverse topics related with Indian and World History. This Club is first of its kind to be introduced at college level in India.

10.The college provides pure and cold drinking water to the students. The college canteen offers variety of food items to students at reasonable rates.

11.The safety and security of students is of utmost priority. Fire extinguishers are installed at various places.

12.The students are encouraged to participate in various extracurricular and co curricular activities. Students participate in



Sports competitions at various levels and successful candidates are felicitated.

13.As per recommendation of NAAC, a Women's cell was set up by the college to address various issues related to women empowerment and betterment.

❖ **Governance, Leadership and Management**

1.The Governing Body of the college plays an important role in management and development of the college. The GB meets at regular intervals to monitor the smooth functioning of the college, to initiate various development programmes.

2.Various committees are set up for decentralization of power and to ensure an overall monitoring and development. The committees have the power to function independently and the decisions are duly implemented.

3.The GB sanctions funds for maintenance as well as development programmes of the college. It ensures that the funds received from various central and state government agencies are effectively utilized.



4.For smooth functioning of the college and to maintain a healthy teacher student ratio, the GB took initiative to appoint teaching as well as non teaching staff on casual basis. Steps are taken to fill up the vacant teaching and non teaching posts sanctioned by the Government.

5.The IQAC of the college takes necessary actions to improve the overall performance of the college. It integrates modern methods of teaching with existing ones, ensures adequate allocation of funds for academic cause. Various seminars, lectures are organized to maintain the parameters of higher education. Teachers are encouraged to take up various research projects.

6.The teachers are encouraged to go on UGC faculty development programme for Ph D dissertation. Attending Orientation Programmes and Refresher Courses are given importance.

7.Governing Body makes sure that the Government regulations are strictly observed during recruitment. The Principal is directed to keep record of the attendance and performance of the staff members.

8.Proper maintenance of records related to finance and regular audit is ensured. The Accounts Department and the office are



equipped with office management software. Computerization of salary accounts has been done with due assistance from the State Government. The college plans to go for complete online admission w.e.f. 2015. Financial assistance has been received from State Government.

❖ Innovative Practices

1)With the aim of fostering gender-sensitivity and effectively meeting the problems of female-students, our college had instituted a '**WOMEN-CELL**' in 2009. The cell seeks to create awareness among the female-students regarding their overall development through organizing seminars, holding discussions, exhibiting their paintings and their crafts.

2)A wall magazine has been introduced by the forum by the female students of our college.

3)The teachers employing the best practices in teaching and learning engage the students actively in their studies amongst themselves as well as with the faculty members and implement regular and periodic assessment in order to evaluate how well their programme is in meeting the objectives.



4)The teachers refer to the use of modern tools, such as computers, digital technology, [electronic media](#) with interactive exercises that facilitate learning.

5)Keeping the issue of environmental protection in mind, developing a green belt within the college campus is one priority area.

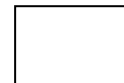

❖ History

❖ Curricular facets

In the past 67 years of its existence, Dinabandhu Mahavidyalaya has been unwaveringly faithful to its prime mission of offering quality education at an affordable expense. ❖ Academic affairs of the college

a)The Academic Committee, comprising of all heads of Department, meets at the commencement of new session to discuss the academic calendar, routine and other related issues.



b)Proposals for guest lecturer appointment are put forward to the authority for Departments having scarcity of teachers.

c)When the prolonged absence of students in a particular course is reported, necessary steps are taken to inform the guardians. The Heads of the Department meet the guardians and discuss the possible outcomes of absence.

d)Many teachers of the college are members of the undergraduate board of studies of West Bengal State University and thus play an active role in curriculum design of the University.

1.3 Curriculum Enrichment:

The college is affiliated to West Bengal State University and does not have the power to design any course at undergraduate level. The subject combinations are at par with the rules of the University. However, depending on the demand of the students, permission to open a new course is sought from time to time. Honours in Geography has been introduced and Honours course in Education is in the pipeline.



The University organizes meetings of different subject teachers from time to time to review and suggest modifications in syllabi ,if any. The faculty members attend such meetings and keep themselves informed of the changes in syllabus, the question pattern etc.

There are a few subjects in which there are representations to the UG Board of Studies and the members do their best to co operate with the University to upgrade the syllabus.

A new policy has been adopted for motivating the students of General Stream of lab based subjects to attend classes regularly. They are assessed on a regular basis and the merit reflects in their final scores.

At PG level in Bengali, there is autonomy. The members of BOS, external as well as internal review the syllabus every alternate year, thus making the students at par with other Universities.

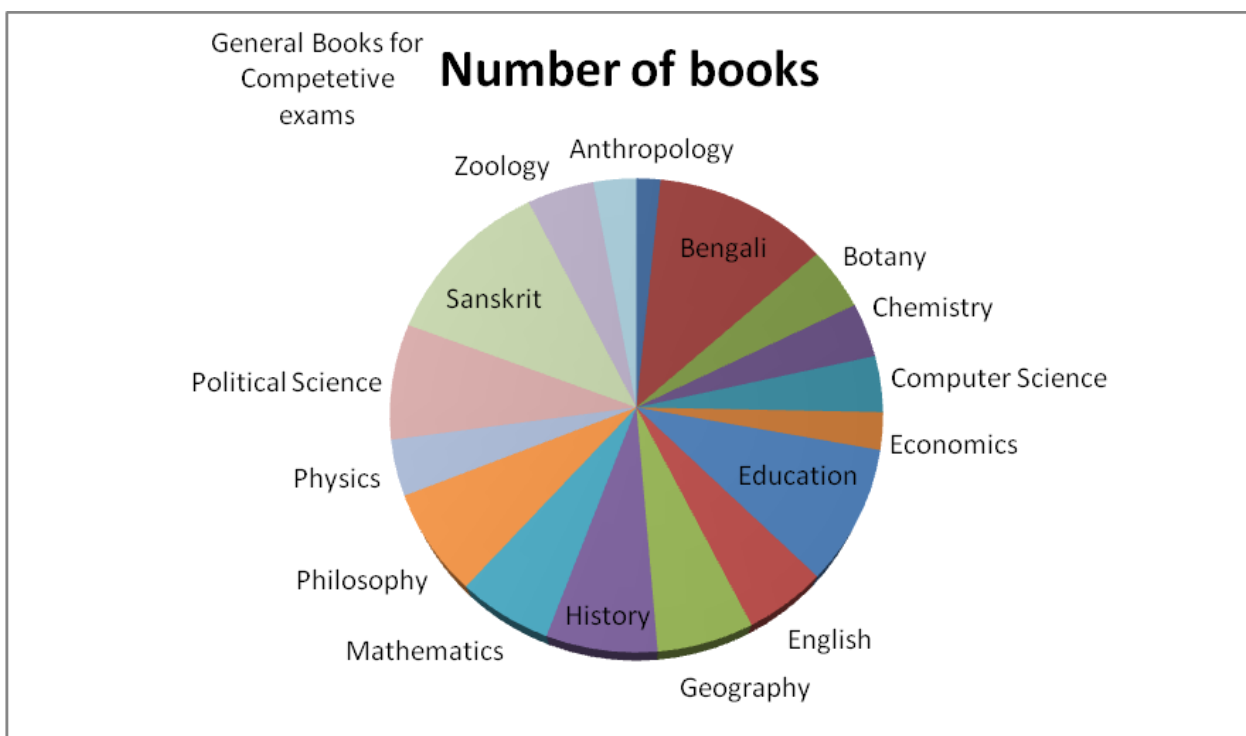
1.3.1 Remedial Coaching

1.7 Learning Resources:

The college authority takes initiative in providing students with latest technologies in learning:

The college has a smart classroom to promote ICT based teaching. Teachers are encouraged to follow audio visual techniques in teaching. Two classrooms are provided with LCD Projectors and seven classrooms are equipped with Public address equipments.

The central library of the college has 16381 Books. In addition the college subscribes magazines and periodicals. The college library is



automated and has registered under INFLIBNET-NLIST which gives access to above 90,000 e-books and 6000 full text journals.

The teachers are encouraged to organize seminars, regional as well as National where eminent speakers are invited.

Interdisciplinary talks and seminars are organized at college level.

The History Club of the college holds seminars at regular intervals where teachers of the college and from outside are speakers.

The laboratories are well equipped and receive funds from the college for upliftment and maintenance. There is a computer laboratory with eight computers. There is only one Assistant Professor against one post sanctioned .The college has recruited 1 guest Lecturer for Computer Science department. In addition there are thirty two computers distributed among other departments of the college. Each department has a Departmental Library. A detailed report of the library is presented in the latter section.

1.8 Other facilities:

An auditorium with a seating capacity of 250 to host seminars and training programmes.

Each Department is provided with computers and internet connection.

A multi-gym was set up in the college in the year 2011, as per the recommendations of the NAAC peer team.

Teaching, Learning and Evaluation

We sincerely believe that the best result with respect to student learning outcome results from active participation and interaction on the part of both the teachers and students. The teachers employing the best practices in teaching and learning engage the students actively in their studies amongst themselves as well as with the faculty members and implement regular and periodic assessment in order to evaluate how well their programme is in meeting the objectives.

2.1.1 Transparency in admission

After the declaration of 10+2 results, the notice for admission is posted on the college website. The number of seats in each course, the eligibility criteria and reservation policies are made available online. Since the college plans to go for complete online admission w.e.f the session 2015-16 only, presently the students submit the forms at the college and procure the college prospectus.



After being scrutinized manually, the applicants' details are fed to the college admission database. After the closing of form submission process, a merit list is generated and is posted on the college website as well as on all notice boards in and around the college.

The dates for counseling are finalized by the faculty members and announced. The candidates are required to come to the college on the stipulated dates along with their testimonials for verification.

The provision to change the Major subject or the pass combinations is kept open provided it agrees with the intake capacity and a balance among all subjects is maintained.

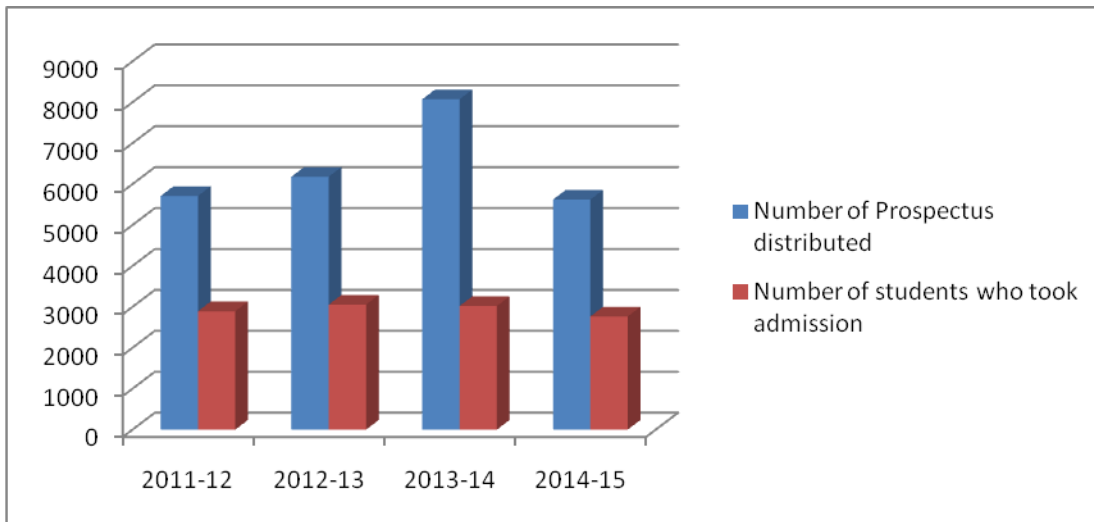

2.1.3 Admission to Undergraduate courses

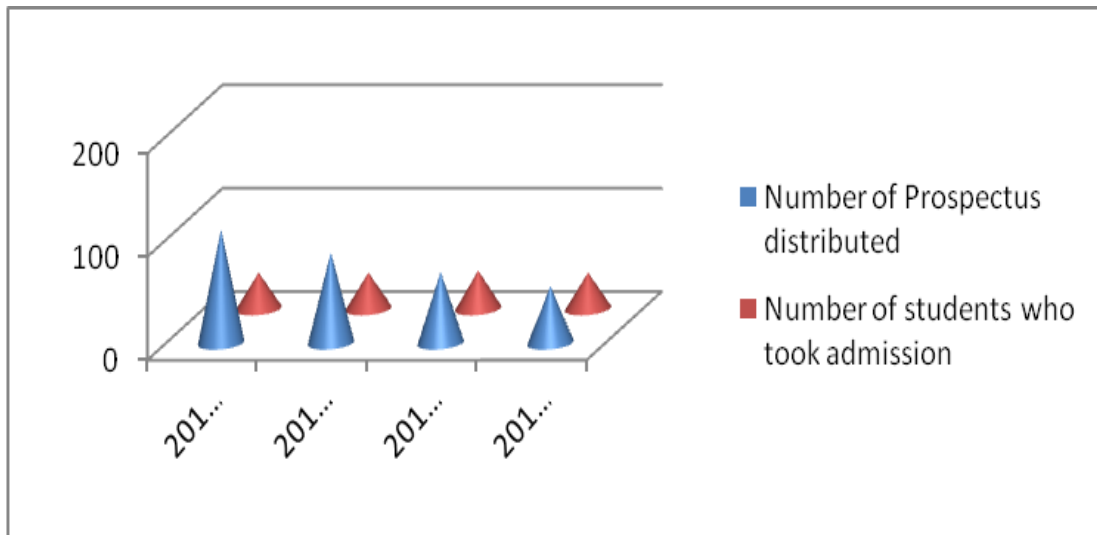
2.1.4 Admission to Post Graduate course

2.1.5 Admission Committee

Every year Admission Committee of the college is formed comprising of IQAC members, Teachers' Council Secretary, senior Teachers, non teaching members of the staff and a representative from the Students' Union. The committee meets before the beginning of the process to set the rules and dates. Once finalized, they are circulated through local network, notice boards and website.

The students download the form from the internet and submit the same at the college. At the time of submission, they are required to procure the Prospectus on payment. The serial number of the prospectus is mentioned on the application form and an acknowledgment on the prospectus on receipt of the application is made to avoid mishandling. A student can apply to a maximum of four courses with a single prospectus.

The admission committee keeps a record of the number of submissions and at the end of the submission date, arranges for verification by the concerned department. After verification and corrections, if any, merit list is prepared and published. The counseling dates are announced and the subject wise counseling is done in presence of Departmental teachers, staff and representatives of Admission Committee.

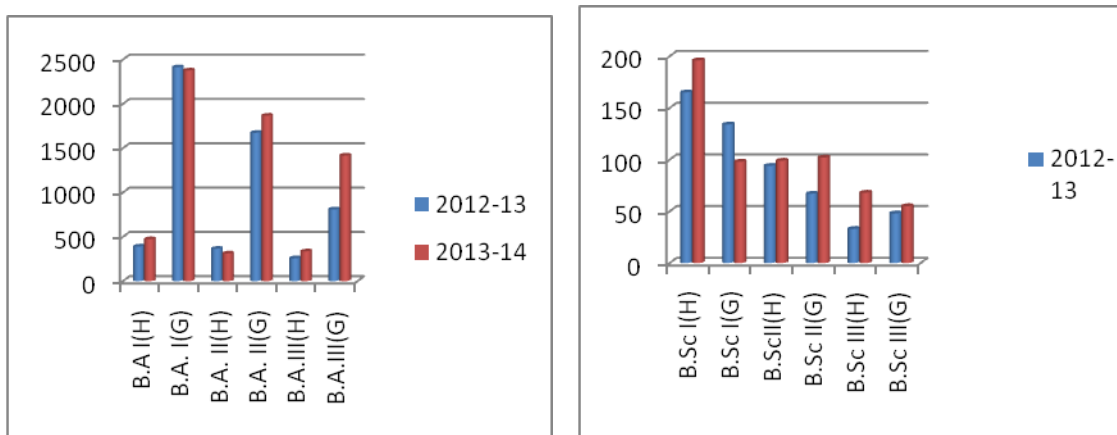

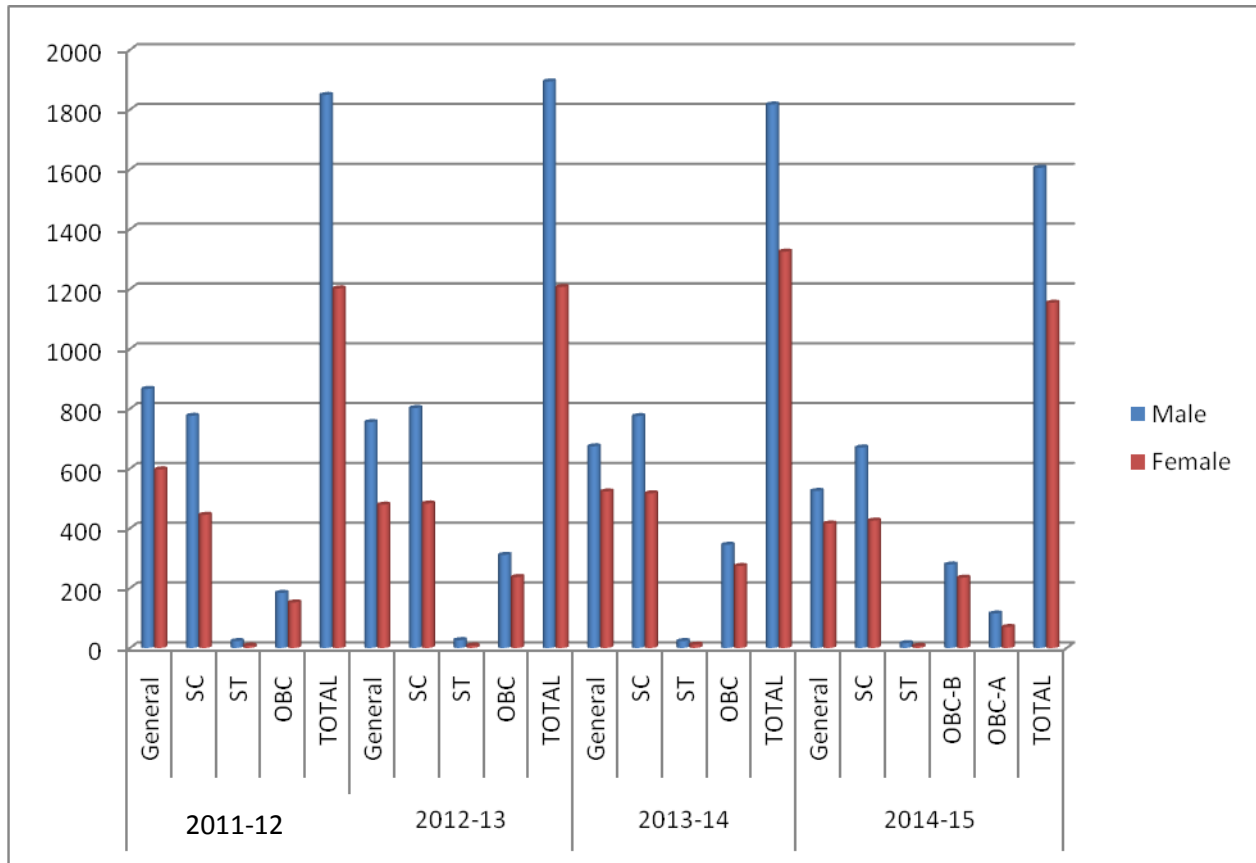

Figure 2.5: Teaching Staff

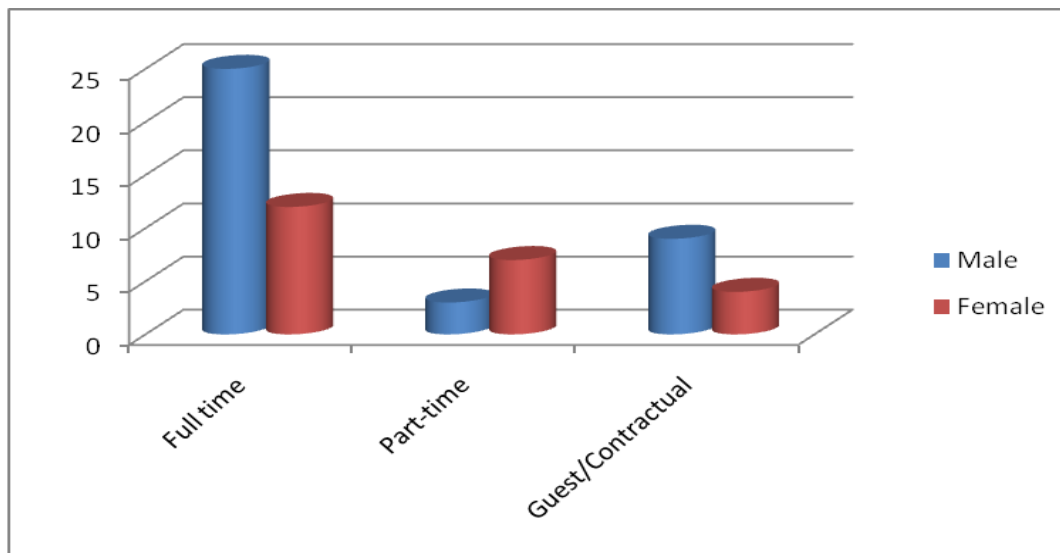
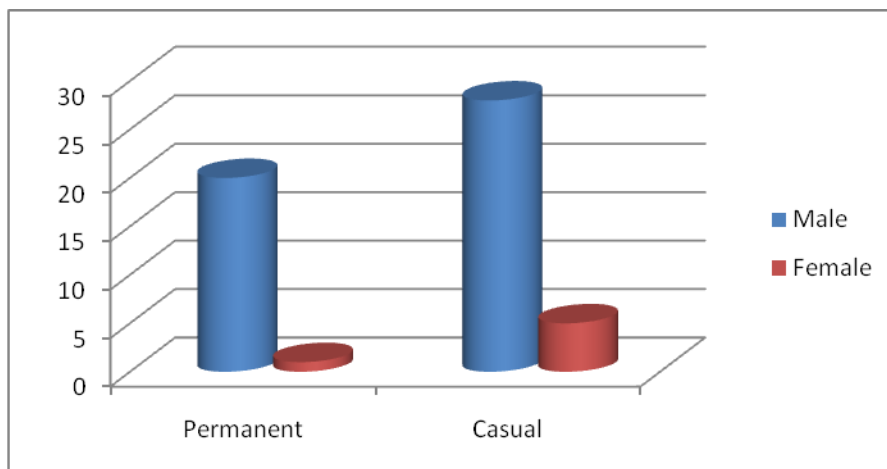

2.2.2 Provision for differently abled students: The college has a ramp for physically challenged students. Since the building does not have any elevator, it is assured that the lectures are held on the ground floor. The members of the staff extend their support as and when needed. The construction of a toilet for differently- abled candidates has been proposed. The college has prepared a list of books in Braille for the visually challenged students. It must be noted that there is no visually challenged student enrolled in the college.

2.2.3 Academic support for slow learners: The teachers assess the academic progress of the students through one to one interactions. Students who are weak are offered special attention. Tutorials and extra classes are organized. Students are suggested to opt for Remedial classes. In the laboratory based subjects, the students having Honours have access to the Department at all times. During free period, they are advised to sit in the Department and access the books of the Departmental Library.

2.3 Teaching and Learning

2.3.1 Planning of curriculum implementation

Before commencement of the new session, the Academic Calendar is prepared in consultation with the probable dates of University Examinations. The routine is circulated amongst the students on the date of admission. Since looking after the academic affairs of the college requires all time attention, the Principal in consultation



with the Governing Body of the college, has appointed a senior teacher as the Academic in Charge. The said person is responsible for drawing the routine, to assure that every faculty member is assigned classes in accordance with UGC norms. The A-I-C keeps an eye on the day to day academic matters, holding of classes at stipulated hours, students' attendance.

In the laboratory based subjects (Honours), every teacher is allotted a minimum of 18 classes per week, per Honours subject and 9-12 classes per General subject. Each class is of 40 minute duration. In addition to these classes, students are free to ask for extra class or practice hours in the laboratory. For students of Final Year Honours, the teachers dedicate extra hours everyday. There are Departments where the number of teaching staff is scarce and so the extra load is shared among the present teachers increasing the number of classes to 30-32 in some subjects.

The University has revised the syllabi of all undergraduate courses in 2009-10, 2010-11, 2011-12. Students are informed of the modified syllabi and question pattern.



Teaching plans are made according to the Academic calendar. Teachers maintain records of the classes taken and the Governing Body directs the Principal to check and verify such records.

The Academic sub-committee is composed of Heads of the Departments or senior most teachers and meets regularly to discuss the difficulties being faced in completing the syllabus. At times, when the demand is high, the college authority takes measures to employ teachers on contractual basis in some subjects.

Students are advised to refer to the Question Bank provided by the University and to the previous years Question papers. The Central Library has archived the previous years papers and it becomes convenient for the students to refer to.

2.3.5 Student Evaluation

1) The college holds a Test Examination well before the commencement of the University Examinations. The papers are evaluated and the result is published. The answer scripts are shown to the students. This enables the students to gauge their



weak areas and work on them. In addition each Department holds tests and open discussion to evaluate the condition of students.

2) The students are evaluated on a regular basis depending on their performance in the practical classes, attendance, viva voce and in case of field base subjects on the field report as well. The University has introduced this scoring system for general subjects so that students attend the Practical classes and gain on hands experience.

3) Tutorial classes are allotted in the time table for undergraduate courses.

4) Evaluation at post graduate level: The college offers post graduate course in Bengali. Each semester carries four units, each of 50 marks out of which 10 are awarded by the Departmental teachers depending on the class performance of a student: Internal Assessment. The PG Board of Studies decides the paper setter for each module as well as list of examiners. At the end of each semester the students are awarded their performance reports. The division awarded to the students is decided by the percentage they obtained. The entire process is according to the guidelines of West Bengal State University.

However, due to the fact that the Bengali department is run by four full time and one part time teacher and they have the added responsibility of the post graduate course, in addition to the

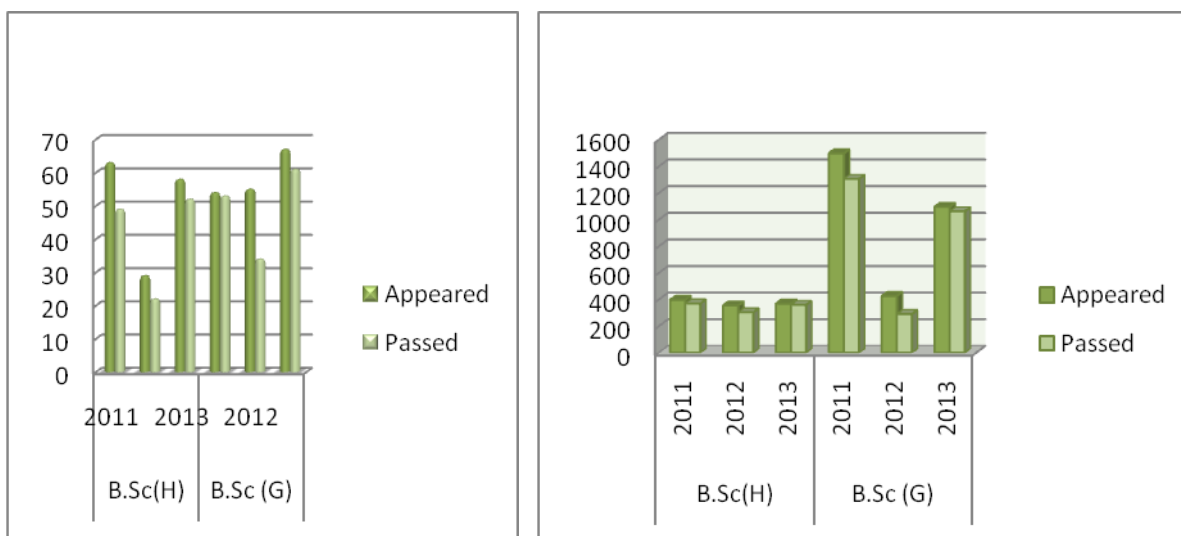
undergraduate course of the University, the students can opt for only a single special paper. Initiation of other special papers will come to effect shortly.

2.3.7 Role of the Internal Quality Assurance Cell (IQAC)

2.3.8 Facilities available for student centric learning

The college is at the banks of Ichhamati river far from the hustles of a busy life. The total area of the campus is 13 acres 39 acres. There is an administrative building which lies just near the entrance. The Students' Union Room, the canteen also lie outside



the class premises so that the students experience an atmosphere conducive to learning.

There is one block for holding classes of the Science stream and other block for humanities stream. There is an annexe building where usually classes of Humanities stream are held.

The laboratories are well equipped . However the laboratory space needs to be increased for Departments running both Honours and General courses since the number of students attending General courses is large and also there is a need to increase the number of sets for every experiment. The college authority provides contingency and funds as and when required for purchase of new apparatus but a master plan needs to be made wherein a block exclusively for laboratories needs to be constructed along with classrooms for Honours classes. There is a scarcity of classrooms in the college due to which many Departments hold classes in cubicles constructed within the Departments. This is one of the major drawbacks of the college and needs immediate attention.

All departments are provided with internet connectivity and Departmental Library. In addition to the books from Departmental Library, e resources are provided to the students

The central library has 16381 subject books , 486 books in the reference section. In addition the INFLIBNET-NLIST facility makes it possible to access 90,000 + e books and 6000 full text e



journals. The books in the reference section can be used for career guidance by the students. The access is open to all the regular students of the college. The career guidance books and periodicals are displayed for ready reference. The students can search for required books in the catalogue corner or through OPAC. Steps to encourage the use of OPAC for efficient usage of library services have been initialized.

- ❖ **Library Layout:** The 1680 square feet well ventilated, intelligently lighted up and comfortably furnished to partially automated library with a seating capacity of about 100.
- ❖ **ICT Infrastructure and Know how:** The library has four computers, printer, scanner, barcode reader, Xerox machine, LAN, Broadband Internet facility.

The teachers in many departments employ audio visual teaching aids to make the content interesting for the students. There are two classrooms with audio visual arrangements and one seminar room which has a smart board and can be requisitioned for use.

Remedial Coaching is provided for students who need special care and assistance. Extra teaching hours are devoted to the Honours students.



Students studying Geography, Zoology, Botany and Anthropology have to participate in field work and prepare field report which enables the students to draft and prepare report scientifically.

Bhasha Divas is observed on International Bhasha Divas wherein talks are delivered by the faculty members. The college also observed Rabindra Jayanti where a cultural program was organized by the teachers.

Other special dates like Women's Day , Teachers' Day are observed. This year in compliance with the directive of the Central Government, Ekta Diwas was observed on 31st October marking the birth anniversary of Sardar Vallabhbhai Patel. These observances enrich the social awareness of the students and help in overall development of the students.

Students are motivated to participate in Mock Parliament at various levels. The teachers of the college guide them and the outcome is that students bag prize at District as well as State level.

The college has two units of NSS and the students register themselves and participate in various programmes of social awareness. The NCC companies of the college are very active and the cadets participate in camps regularly.

There is a career guidance cell in the college. The activities of this cell are limited owing to the reduced demand among the students.

Also owing to the location of the college, its very rare that reputable companies organize recruitment drives.

The college campus has two big playgrounds which is used effectively by the students for playing various outdoor games. The Sports Department houses various facilities which the students can avail. There is a gymnasium within the campus.

The NCC organizes its daily chores at one of the grounds. Recently the college was requisitioned by the NCC for holding camps. Cadets from various schools and colleges attended it and motivated many students to join NCC.

2.3.9 Role of the college authority in implementation of strategies

The Academic in Charge keeps record of the classes being held at stipulated hours. Any deviation is brought into the notice of concerned teacher. Attendance of students is monitored by



Departmental teachers and any long absence of is reported to the guardians.

For ensuring academic upgradation of faculty, teachers are encouraged to attend workshops, seminars and orientation programs.

2.3.10 Innovative processes adopted by the institution in Teaching and Learning

The college has utilized grants received from UGC efficiently to provide two classrooms with LCD Projectors. Two laptops have been procured for teachers who do not carry their own laptops. The teachers are encouraged to provide instruction through multimedia, this has the advantage of making the subject more interesting by showing short animations based on the topics taught.

Often students are provided with soft copies of the matter taught in the class.

The teachers are provided with microphones to address the classes where the student strength is high.

There is a smart board in the seminar hall which can be used by teachers to deliver lectures.

Students in the classroom are sometimes divided into small groups and assigned a problem. This is more often in the Practical



classes where an experiment has to be performed co operatively. Students develop the habit of thinking and working in a group. The students then go out and assist others in the group, this heightens their confidence and understanding of the subject.

The teachers while introducing a subject first try to give an introduction of the applications of the same by giving examples from daily life. This makes the subject clear and creates a long lasting memory. Many teachers have a good sense of humour and this makes long lectures not only informative but also interesting and helps maintain a cordial rapport between the teachers and students.

2.4 Teacher Quality

2.4.1 Recruitment of teachers

As and when vacancy arises due to superannuation or transfer of a teacher, a requisition is made to the West Bengal College Service Commission (WBCSC) for appointing a teacher against the vacant post. 100 point Roster is duly maintained. Upon receiving recommendation from the WBCSC, appointment letter is issued to the candidate after resolving the same in the Governing Body meeting. The recommendations by WBCSC are in compliance with UGC norms. Relevant documents are then sent to the DPI. The college has appointed 3 teachers through WBCSC during the last four years. In addition there are 10 Part Time Teachers sanctioned

by the Government. Responding to the need of the students in different subjects, 11 Guest Lecturers have been recruited by the college for undergraduate courses.

2.5 Examination reforms implemented

The college is affiliated to the West Bengal State University and abides by the rules framed by the University for holding exams at UG level. The University has introduced weightage on internal assessment from the session 2009-10. 80% marks are awarded by the internal examiners based on the regular performance and attendance of the students. For the rest 20%, a viva voce is conducted.

Regarding holding of theoretical papers, the college follows the rules set by the University. Any reform or modification is brought to the notice of the authority and steps are taken to inform all.

At college level, about two months before the commencement of examinations, tests are held following the University pattern and the scripts are evaluated and shown to the students. This acts as a preparatory test for them.



The college has a Central Examination Committee for holding of the University examinations. It is through effective management of all members that fair conduct of examination is possible. Finally, the teachers are assigned evaluation duties by the University and its one of the rules that no teacher gets to check the scripts of students of his college. Efforts to publish the results at the earliest are made. If the students are not satisfied with the marks they obtain they can apply for review.



Criterion 3: Research, Consultancy and Extension

Dinabandhu Mahavidyalaya has always been keen and enthusiastic to extend its horizon to the development of research work amongst its faculty members. It also tries its best to inculcate the significance and interest for research to its pupils. It has always been our honest endeavour to institutionalize a spirit of research and development of a sense and an environment of creativity through promotion of increasing involvement of faculties in various kinds of research activities which could culminate into quality publications, extension of various new prospects and academic linkages.

The college tries its utmost to provide teachers with the facilities needed for these activities across its capacities. The college encourages teachers to apply for grants, participate in collaborative and research based extension programmes and in national and international conferences organized by the college and other institutions. They regularly organize state and national level conferences and seminars in collaboration with other institutions.

The college has always been committed to inculcate the spirit of campus to community research culture and the departments



are encouraged to undertake community-oriented research projects. Access to e-journals and e-books has been made possible through N-list INFLIBNET.

3.1: Promotion of Scientific Temper, Research Culture

Promotion of Scientific Temper and development and sustenance of research culture is considered as one of the important areas in our institution and is usually achieved through the following measures taken up:

1. An environment of research culture and exercise of knowledge is built up through Departmental/State/National level seminars, conferences, workshops, departmental publications, faculty consultancy to students. Invited talks by eminent resource persons in various disciplines are delivered. Students enrich themselves by listening to these talks and by interacting with the students.
2. A rich research-friendly library resource of about 6000 e-journals and more than 90000 e-books through N-List has been made available for the students and the faculties.



3. A Research Committee has been established for the promotion of research in the and encouragement of the faculties and to facilitate the faculty members. This committee works under the chairmanship of the Principal / Teacher in-Charge and members amongst faculties involved in research activities.

This committee works to enhance the participation of the faculties in research works, submitting new projects and also provides assistance for the administrative requirements for smooth running of ongoing projects. It also arranges for the evaluation and review of the technicalities of research proposals before the submission of the same to the funding agencies.

3.2: Recent recommendations of the Research committee:

The committee recently recommended for begin with allocation of financial grant to faculty members for pursuing research activities and it has been agreed by the college authority.

It has also recommended the facilitation of research activities by providing adequate time slots by offering flexible class schedule for those undertaking Ph.D. coursework.

3.2.1: Promotion of research activities:

The Government of West Bengal has no provision for Sabbatical Leave. The college faculty makes optimal use of their study leaves, preparatory days, holidays and vacation on purposes



related to research. A good number of teachers have completed or are pursuing active research on part-time as well as full-time basis and, therefore, are provided with infrastructural and other support services within the campus. They are allowed a flexible class schedule. They are also granted with short study leaves for course work, PhD work as and when required. Three faculty members have availed the UGC Faculty Development Programme (FDP and erstwhile FIP). Two of them (Dr. Debjani Bhattacharya of Economics and Dr. Raja Chakraborty of Anthropology) have been awarded Ph. D degree and Ms Bittoo Rani of Political Science is awaiting award of degree. The college also remains happy and liberal to sanction on-duty leave to participate in academic conferences and seminars.

3.2.2: Outcome:

One faculty member was granted DST-funded major research project in 2013. However, due to the migration of the faculty member to the University of Calcutta, the project has been recently shifted to that university.

One faculty member from the Botany department of the college has recently applied for another UGC Major Research Project.

Five minor research projects (MRP) funded by UGC has been completed since 2006 and at present 02 faculty members are pursuing MRP funded by the UGC.



The college is equipped with Internet facility in every department for the use of the teachers and the students.

The faculty members of Anthropology department have been undertaking community-oriented research programmes and the results are continuously getting published in reputed journals and other volumes.

The faculty members of Anthropology and Physics have established research collaborations with eminent academicians from national and international institutions of high repute. These collaborations are both in the form of joint research projects as well as joint publications.

3.3: Institutional Efforts for Smooth Progress: Implementation of research activity:

To promote and ensure smooth progress/implementation of higher research, a number of measures are usually adopted by the college.

Principal Investigators of the research projects are provided adequate autonomy in conducting the research work.

Funds sanctioned by the Central/State government or other agencies to the Principal Investigator released without delay according to stipulated norms.



Necessary infrastructure, manpower and other support services are always provided within the campus. Lab, library, internet, software etc. are always at the disposal of the scholars.

E-journals and e-books are available from INFLIBNET N-list and other open source e-contents.

Faculty members on UGC-approved posts sanctioned study leave under Faculty Development Programme (FDP), flexible teaching schedule (with a safeguard to the relevant extant service rules) to pursue their M.Phil./Ph.D. programmes/coursework.

They are also granted flexible teaching schedule as well as full paid on-duty leaves adjusting the class schedule. They are also allowed to avail short study leaves for various coursework, workshops, Refresher Course, Orientation Programme etc.

Leave is also sanctioned to enable teachers to participate/present papers indifferent seminars and conferences and also to undertake research methodology training.

3.4: Faculty research activities and contributions

3.4.1. Publication:

As on record, the faculties of this institution has published 53 research papers (since 2004) in International journals, 37 in National level journals and 29 papers in state level journals.



7 books have also been published by the faculty members. Among these, a special mention may be made of the recently published International edited volume on Human Central Obesity, jointly edited by one of our Anthropology faculties, Dr. Raja Chakraborty, and published by NOVA Science Publishers, New York. This volume is graced by article contributions by internationally reputed scholars from all over the world.

3.4.2. Research Projects

3.4.2.1: Major Research Project:

One of our Zoology faculty, Dr. Amlan Das, who is now working in the University of Calcutta, had received a research funding from the Department of Science and Technology (DST), Government of India, in the form of a Major Research Project.

3.4.2.2: Minor Research Project:

Our faculties have received 16 Minor Research Projects from the University Grants Commission (UGC) since 2004 and most of have been successfully completed and some of those are ongoing projects, These research works have resulted in a number of publications, academic discussions and PhD awards.

The college authority as well as our rich academic niche has always been conducive for establishing collaborative academic activities including research works involving academics of other institutions. Mention in this regard may be made of our faculty members from Physics and Anthropology departments who have established research collaborations with eminent academicians from national and international institutions of high repute. These collaborations are both in the form of joint research projects as well as joint publications.

- Dr. Sudeshna Lahiri of the Department of Physics has research collaboration with Dr. Dola Roy Chowdhury, Techno India, and Professor A. N. S. Iyengar of the Saha Institute of Nuclear Physics (SINP) Kolkata.
- Dr. Sharmila De, Associate Professor of Physics, collaborated with Professor Papiya Nandy, Jadavpur University, to guide a research dissertation which produced a PhD thesis and degree awarded by Jadavpur University.
- Dr. Raja Chakraborty, Dr. Rana Saha and Dr. Mithu Bhadra of the Department of Anthropology published a number of scientific papers in reputed journals and edited volumes in collaboration with renowned researchers belonging to reputed institutes like the University of Oxford, Indian



Statistical Institute, Polish Academy of Sciences, University of Lodz and Wroclaw University of Environment and Life Sciences, Poland, Vidyasagar University, Midnapore, North Eastern Hill University, Shillong etc. Dr. Raja Chakraborty is continuing with a long-standing research co-operation in the form of joint publications with Professor Kaushik Bose of Vidyasagar University, Midnapore, West Bengal, and also with Dr. Slawomir Koziel, Associate Professor and Director, Polish Academy of Sciences Unit of Anthropology in Wroclaw, Poland.

3.5: Research and project Guidance

- Dr. Sharmila De, a faculty of Physics, has supervised a PhD work which was awarded by Jadavpur University, Kolkata.
- Dr. Rana Saha, Assistant Professor of Anthropology, has supervised three project works for the course of Master in Social Welfare under the Netaji Subhas Open University.
- Dr. Sudeshna Lahiri is supervising one project work for the course of Master degree in Physics under West Bengal State University.



3.6: Post-Doctoral Fellowship and awards

Also, at present, 09 teachers are persuading their PhD research.

3.10: Research Consultancy

The college also started encouraging the faculty members to extend their expertise as research and academic consultants to other institutes and organizations engaged in education and human welfare.

- Dr. Raja Chakraborty, our anthropology faculty member, has acted as a research consultant and resource person in Tribal Research and Training Center, Chaibasa, Jharkhand. As a resource person he conducted training programme for the health workers and animators of the organisation. He initiated there a research programme on assessment of nutritional status of *Ho* tribal people in 21 villages. This endeavour is in progress now.
- Dr. Chakraborty has also recently acted as consultant and resource person for *Terre des Hommes*, an international organization working for the interest of the marginalized people and the children. The collaborative efforts in



connection with data analysis and research with the available data base of the organizations is under progress.

CRITERION 4: Infrastructure and Learning resources

Infrastructure is an essential part of any educational institution. Without appropriate and adequate infrastructure, no academic institution can fulfil its avowed aims. An educational institute can perform properly only when there is healthy synergy between its students, its faculty, and its staff. An apt and adequate infrastructure is one of the major factors to ensure this. With this realization in mind, this institution works towards maintaining an infrastructure that successfully facilitates the teaching-learning process.

One of the prime ingredients of infrastructure of an institution is the learning resources it provides to its students. Hence, this institution accords premium value to provide the best possible and learner-friendly learning resources to its students. The infrastructural details of the college along with relevant information regarding its learning resources are stated below.



4.1.1: Role of Institution towards improvement of infrastructure

- The college is situated in a rural area and caters to the need of economically and socially backward classes in general. Since this is the oldest college in the subdivision, the demand of the local students to get admission in this college is phenomenally high. The college campus measures about 13.39 acres; however there is immediate need to extend the building to accommodate the ever-increasing population of students. The college authority makes sufficient budgetary allocations, as and when required, for construction of new laboratories, upgradation of the existing laboratories and classrooms. In view of the increasing student strength and the inclusion of new subjects, the total built-up area of the college has been increased.



- The laboratories need to be extended. The authority understands the demanding situation and has been taking steps to address this need. The Governing Body of the college had sanctioned a budgetary allocation for construction of an Administrative Block. There is a cycle shed and Students' Union Room on the ground floor; the first floor houses all the support departments of the college: the cash section, Accountant and Cashier's office and the main office. The office is automated and there are 8 computers out of which 6 are connected by LAN.
- On the second floor is the Principal's chamber, Principal's office, a crèche and two Guest Rooms. The entire ground area of the building measures 480 sq.m.
- Construction of one floor over the existing annex building has been carried out . The Governing Body realized that the laboratories must be shifted from ground floor after the devastating flood of 2004. The top of the annexe building has been allotted to the chemistry laboratory. Also a connection



has been made between the main and the annexe building and space for departmental offices of English, History, Education, Political Science, and Economics has been provided. Each department has been provided with a library and a computer with Internet connection under NME scheme.

- The Zoology laboratory needed to be extended and renovated. There was no proper plumbing and water connection which is a prime requisite of these laboratories. The Governing Body sanctioned a fund for extension of the Zoology laboratory, made proper plumbing and water connections on the working tables as demanded by the Department. A Departmental office was also set up.
- A computer laboratory consisting of an adequate number of computers has been set up.
- The computers are regularly updated with the state-of-the-art software and maintenance work is performed by qualified professionals at regular intervals.



- The Botany Department needs to be extended and renovated. The primary work has been initiated with the fund of Rs 10 lakhs received from the State Government for improvement of infrastructure. However the total expense would be approximately 20 lakhs, the difference would be borne by the college.
- The building being very old, maintenance requires a substantial fund. The college authority has spent approximately Rs 3 lakhs on the roof treatment. Repair of the Physics lab which needed urgent attention has been done by the college authority.
- A telescope for astronomical observations is being procured by the college to motivate students. The objective is to provide all facilities under one roof so that apart from academics, the students can nurture hobbies which promote an overall development.
- A students canteen has been constructed by the college which caters to the need of students as well as teachers who commute daily between far off places to this institution.



- A cheap canteen for providing stationary to students, Xerox facilities has been initiated.
- With an eye to provide education in sync with the technological advancements of the day, the college includes an auditorium with a seating capacity of 250 has been constructed from college fund. a Seminar Hall equipped with a Smart Boards; two digital class rooms; and seven classrooms with audio aids.
- In its commitment to effect holistic developments of students, the college encourages students to participate in games and sports not only inside the campus but also in tournaments, athletic events, etc organized across the state and the country. A gymnasium has been set up in the college premises (386.84 sq.m) to enable students to physical development, under the belief that they need a healthy body to have a sound mind. The equipments have been procured using the grant received from UGC under XIth plan. Apart from these, students regularly participate in interactive programmes like quiz contests, mock parliament, etc..A stage for holding function in the open have



also been constructed from the college fund. In view of the increasing consumption of power owing to increased number of connections, WBSEDCL has installed a transformer within the college premises. A Ladies Hostel has been constructed with the financial assistance from UGC. The electrification has been done by the college.

4.1.2: Effective utilization of the financial aids received

- The college effectively utilizes the grants received from the UGC, from the State Government and other quarters for purchase which include computers and related accessories, laboratory equipments, books for central as well as departmental libraries; maintenance and upgradation of the departments and the departmental laboratories, and the library.
- A Ladies Hostel has been constructed with the financial assistance from UGC. The electrification has been done by the college.



- Construction of Boundary wall with financial assistance received from the State Government has been carried out. The funds received from UGC have been utilized in the upgradation of infrastructure, procurement of new apparatus for the laboratories, installation of an eco friendly generator, water purifiers and water coolers, setting up of computer laboratories, purchase of books for the library, LCD Projectors, laptops, computers.
- CCTV monitoring system has been introduced with cameras at important points of the college. However for effective utilization of the system, more cameras need to be set up. Two solar panels for lighting 6 solar lamps have been installed. This promotes use of alternative resources.
- Two classrooms are ICT enabled, seven rooms are equipped with audio aids.
- There is a 45 kV generator installed within the college premises. Provision for pure drinking water to all has been made through installation of water purifiers, water coolers provide cold water during summer.

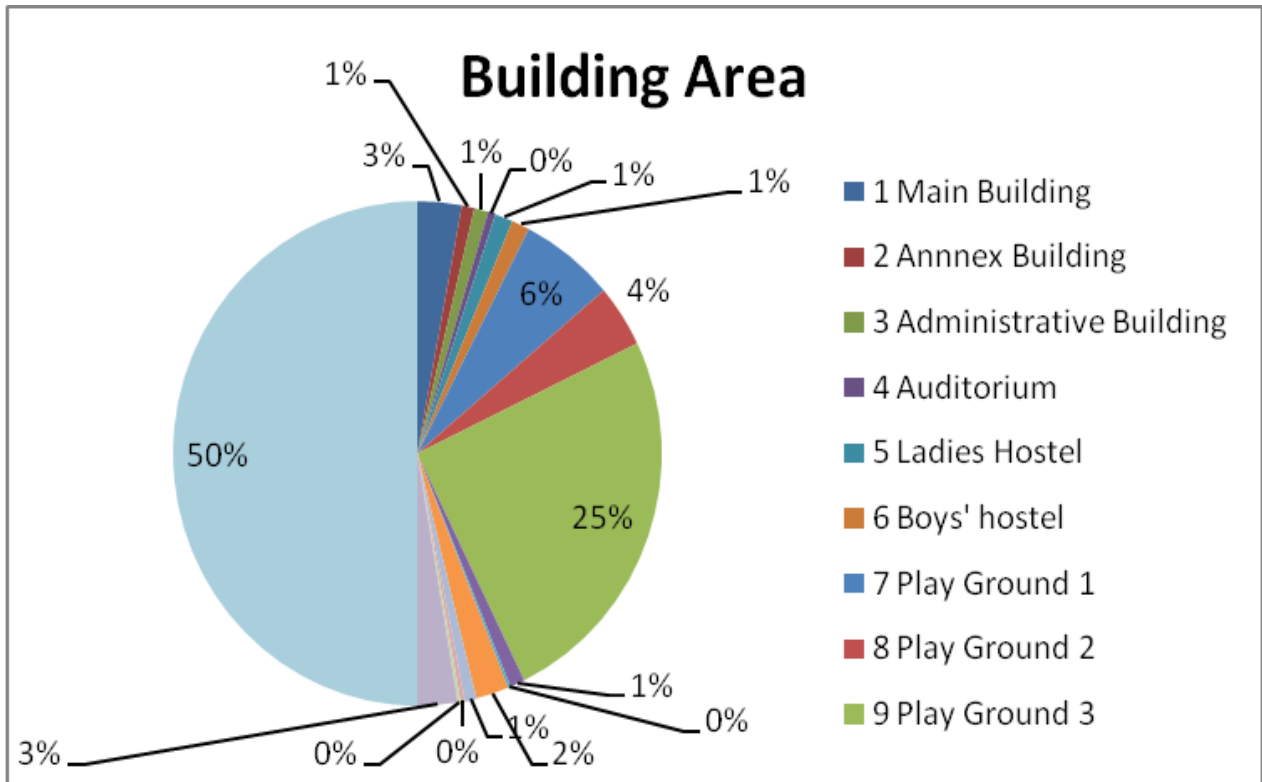

4.1.5: College Library

❖ Objectives:

Library is the knowledge hub of the the academic institution, it is the keystone in the higher educational arch therefore our library aims at realization of institutional objectives by undertaking user-friendly initiatives. It strives to generate enthusiasm and eagerness among the students and the faculty and help them to make best use of the available reading materials supplementing the curriculum.



❖ Library Management:

- **Library Layout:** The 1680 square feet well ventilated, intelligently lighted up and comfortably furnished, partially automated library with a seating capacity of about 100.

The library is under CCTV surveillance. Pure drinking water supply is available within the library.

- **Hours of work:**

i) The library remains open on all the working days except Sundays and College notified holidays.

ii) The Library is open from 10.30am to 4.35pm on Monday to Friday and from 10.30am to 2.30pm on Saturday.

- **Library Advisory Committee:** The effective functioning of the library is ensured by a library committee headed by the Principal (Chairperson), assisted by the Convener, Librarian, representative of various departments & staff.

- **Human Resource Management:**

i) Total Library staff: 07

ii) Librarian: 02

iii) Supporting Staff: 05



The cordial, co-operative and the informed staff of the library keep the library user-friendly by making the dealings easy and comfortable.

- **Library Infrastructure:** Catalogue cabinet, Almirah (Wooden and Steel), Notice Board, Suggestion and complain box for feedback mechanism, Circulation Desk, Journal and Magazine display rack, Newspaper stand, Property counter, Chairs and tables for reading room, Key box, proper lighting arrangement, fan, Aqua guard, CCTV coverage and other furniture.
- **ICT Infrastructure and Know how:** The library has four computers, printer, scanner, barcode reader, Xerox machine, LAN, Broadband Internet facility.
- **Overall policy of the institution about the library:** The library has an approved policy on the collection development supporting introduction of new services, support in terms of funds, annual increase of budget, binding procedure, weeding out of unserviceable books and policy on loss of books and an ongoing commitment of the institution in deputing library professionals for continuing education programmes.

- **Library Budget:** The Library committee annually compiles a budget proposal considering the requirement of different departments to be placed before the principal. Central library and departmental library are utilizing the funds of UGC grants under the supervision of Library committee.

4.1.6 Utilization of the infrastructure

To ensure effective utilization of resources, the teachers are advised to upgrade regularly through use of the facilities available and attending different workshops.

The administrative section is completely computerized with the introduction of office management and accounts management software. Recently the college has acquired COSA as per the guidelines of the Government and with the Government aid.

The facilities we have is extended towards the local administrative requirements; the college is requisitioned by the Government for holding of elections, Distribution and Collection Centre, Counting Centre, Census etc.

The campus is requisitioned during holidays and vacation for holding NCC camps which students from various schools and colleges.

On Saturdays, after college hours and on Sundays, the college campus is used for holding classes of Open Universities (Distance Education)

- ❖ All departments, library, and the office are equipped with broadband connection and are linked to the information superhighway via the Internet. This ensures that students, in addition to teachers, are constantly aware of the latest developments in their respective domains of study and that the academic activities as well as the performance of the office is not hampered in any manner.
- ❖ Coaching is provided to post graduate students for appearing in NET Examinations. Remedial Coaching is provided to SC/ST students of all departments to assist them in areas where they need attention. A library meant exclusively for Remedial Coaching has been set up. Students are provided with training for Entry-in Services so that they are adequately equipped to face career-oriented competitive examinations and are continually cognizant with the demands and requirements of the job market.
- ❖ Awards are given to students excelling in various examinations in order to encourage them to keep them motivated to achieve higher goals.
- ❖ The library is regularly updated through purchase of latest books, magazines and journals. The library is automated with access to 90000+ eBooks ,6000+ e-journals corresponding to



all streams of study. Presently the library contains a total of 16381 print books on various subjects.

4.3.1 CO-CURRICULAR ACTIVITIES:

The college has two NSS Units which organizes various programmes to increase social awareness students. Apart from this, the NSS units perform various social work, like keeping the campus and its vicinity clean, apart from maintaining hygiene within the campus and the neighbourhood, and keeping the student, the staff and the people in the adjacent locality aware of practices that ensure health and hygiene.

The NCC unit of the college, comprising 2 companies, is one of the significant wings of the institution. This is a part of the institution's initiative and commitment aimed at ensuring overall growth of students into responsible citizens devoted to the service of the nation.

4.3.2 Other facilities:

- a. The college has a grievance redressal cell which regularly meets to discuss and determine the course of action regarding the complaints received from students and staff with the intent to maintain healthy atmosphere for students and an atmosphere conducive for working for staff members. The college has a



Women's Cell for guaranteeing a well-balanced learning and working atmosphere free from all sorts of gender prejudices and harassment of women. There is a staff co-operative society which provides financial assistance to staff members and sanctions loans at short notices to the members in case of emergency (with the maximum limit of such loan being Rs 80,000/-).

- b. There is a Ladies' Hostel, which has been constructed using UGC Grant during XIth plan, in the college premises, with a capacity of housing 100 boarders.
- c. The college has a functional RTI Cell for dissemination of information to all and for ensuring the utmost transparency in its activities.
- d. The college has a Boys' Hostel, constructed by BCW Department, Government of West Bengal, with a capacity of 100 seats and a Women's Hostel for SC/ST.
- e. The college premises are under round-the-clock CCTV surveillance to prevent untoward activities, hooliganism, etc. There is a 45 kV eco-friendly green generator for 24 hours' power back up so that the college can function smoothly even during power cuts which frequently occur in the area. The college is equipped with even an alternate source of power in the form of a solar panel for solar power generation. (Financial grant from UGC under various schemes). 5 water purifiers are



installed in various parts of the college premises so that students and the staff can get pure drinking water. In consideration of the sufferings caused during the scorching summer, 4 refrigerators have been installed for providing cold drinking water to students and staff.

- f. All the departments have a departmental office for faculty members and staff, as well as Internet connection and a library of their own.
- g. A laboratory for Computer Science Department has been set up. Also, the Zoology laboratory has been renovated and extended keeping the exigencies of the latest syllabus in view. Next in the pipeline is the extension of the Botany Department for which financial aid from the State Government has been sought.
- h. The Bengali Department has an additional office of its own and a library dedicated to the PG course.
- i. The college boasts of one smart classroom and two halls for ICT-based teaching.
- j. In addition to all the above mentioned facilities for the conventional mode of learning, the college houses are study centres for distance learning under Netaji Subhas Open University, Rabindra Bharati University, and Kalyani University.

- k. The colleges also has a childcare unit so as to enable working mothers to bring their child along in case of urgency. There is a guest room in the college which is used by staff members and guests, as and when required.
- l. A one-time scholarship to BPL category students of 3rd year is provided under the corresponding UGC programme, on the basis of the results. A conveyance allowance to promote regular attendance is also provided with UGC funding.

5.1.3 Financial aid from the college:

In addition to the financial grants under the above mentioned heads, students from poor economic background often approach the teachers for aid. In such cases, the matter is referred to the authority and upon verification of the records, arrangement for aid is made.

An amount of Rs 41,400/- has been granted in 2012-13 while Rs 10,000/- has been granted in 2013-14 from the college fund. It should also be mentioned that no student drops out of the college due to financial reasons. Often students approach the teachers during filling up of forms for examinations citing inability to pay the same. The teachers consider such cases and make necessary arrangements. The teachers also provide the students with subject books if required. However such cases have not been documented.

5.1.4 Special Attention to backward sections:

According to the census held in 2011, 47.06 % of the population belongs to SC community and 2.98 % belongs to ST community.

It must be noted that the percentage of SC, ST population is much higher than the corresponding district records, 20.59% SC and 2.2 % ST.

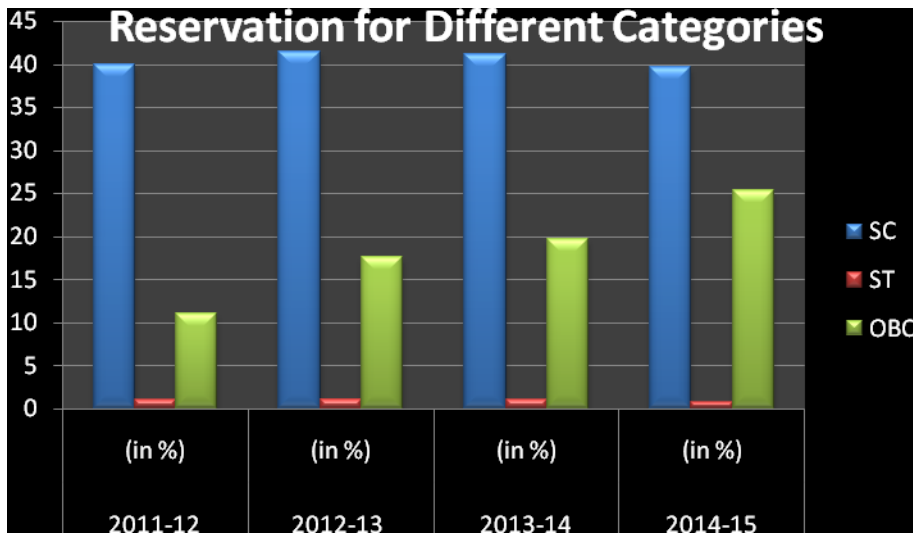
The average literacy is 76% which is lower than the average literacy of the district , 84.06%. The college plays an important

5.3 Student Guidance:

5.3.1 Academic and social development

The teachers of the institution maintain a cordial relation with the students. The students are advised to involve in best practices. Academic counseling is provided to the students. The students are suggested to adhere to the rules of the institution, to prepare themselves for University Examination according to the course pattern. They are informed of the University guidelines and changes in curriculum, if any.

After enrolment, the ANO's of the college give a brief speech to motivate the students to join NCC. Interested students enroll themselves and participate in the programs organized. Everyday the cadets assemble and perform drills on the college ground. This inculcates a sense of discipline, comradeship, secular outlook along with selfless service and sportsmanship.



The NSS officers motivate the students towards social welfare and community building. The students participate in various health camps, environment awareness camps and spread the message of nation building through social service.

5.3.2 Library:

The central library of the college has 16381 subject books and 486 reference books.

In addition to this each department has a library and provides lending facilities to the departmental students. The students have an open access to the departments.

The library is equipped with INFLIBNET-NLIST which makes it possible to access over 90000 e books and 600 e journals.

There is a reading room which is well lighted and spacious.

5.3.3 Hostel:

There is a Boys' Hostel within the college premises with a boarding capacity of 100 and a Ladies Hostel. The Ladies Hostel has been constructed with financial assistance from UGC. However presently the number of boarders in the Boys' Hostel is 20 and there are no boarders in the Ladies' Hostel.

The Hostels provide basic facilities of electricity and sanitation. There is a recreation room and a room for indoor games.



5.3.4 Canteen:

There is a cafeteria in the college campus which is run on a low profit scheme. Tea, coffee, meals are provided at reasonable rate.

5.4 Student Activities :

The college promotes participation in Sports and other extra curricular activities by the students. The students participate in various competitions at various levels. Jersey, sports shoes etc are provided to the students free of cost .

The Students' Union organizes a *Freshers' Welcome* each year to interact with the newly admitted students . Annual Sports and Annual Function are organized by the college. The Students' Union publishes annual magazine reflecting its achievements.

Each department publishes a wall magazine and students are encouraged to contribute articles and write ups.

The students participate in social activities starting with cleaning of college campus, tree plantation by the NSS.

5.5 Career Guidance:

Coaching for NET/SET is provided to the post graduate students of Bengali. There is a library exclusively for this purpose. Teachers of the institution as well as eminent teachers of other institutions provide academic support.



The NCC cadets are motivated to join Indian Armed Forces and a fair percentage opt for the defence services.

5.6 Student Support:

5.6.1: Women's Cell

With the aim of fostering gender-sensitivity and effectively meeting the problems of female-students, our college had instituted a '**WOMEN-CELL**' in 2009. The cell seeks to create awareness among the female-students regarding their overall development through organizing seminars, holding discussions, exhibiting their paintings and their crafts. The cell also seeks to raise awareness towards pressing social issues through signature campaigns. A wall magazine has been introduced by the forum by the female students of our college who eagerly participate in the programmes of the cell.

5.6.2 Grievance Redressal Cell:

There is a grievance redressal cell to address the grievances of the students and staff members. The members of this cell come from amongst the staff members.

Any grievance brought into the notice of this cell through proper channel is investigated and steps for redressal are initiated.



5.6.3 Right to Information Cell:

The Principal/ Teacher in Charge is the Appellate Authority. A SPIO has been appointed by the college. Any information sought by an individual is submitted to the SPIO for necessary action.

5.6.4 Anti Ragging Cell:

An anti ragging cell exists in the college to curb the menace of ragging. Fortunately not a single incident of ragging has been reported till date.

5.6.5 Health Camp

A thalassaemia awareness programme and a screening test was organised by the Health Department, Government of India in the college on 22nd February 2014.

The report has been despatched to the college and the college has distributed the same to the students.

5.7 Remedial classes:

To reduce the number of drop outs and to increase the percentage of successful candidates, Remedial coaching is provided to the weak students. There is a library which was established using the UGC Grant for the same.

5.8 NET Coaching

There is a centre for providing NET coaching to post graduate students in Bengali.

Sri Bhagirath Pradhan cleared NET in Bengali in the year 2012.

5.9 Student Progression

On average 15% of the students passing out of the college opt for Post Graduation under different Universities.

One of the achievements of this college which is situated in the rural belt is that there is a good number of students who clear NET/SET examinations .

6.1 Institutional Aims & objectives and Leadership

Established in 1947,our Institution was the brain child of Dinabandhu Mitra, Bibhutibhushan Bandyopadhyaya and Rakhal Das Bandyopadhyaya----luminaries of20th century Bengal. In the last 65 years of its existence ,our Institution, true to its pledge and vision of enlightening young minds, has been ceaselessly as well as consistently trying for enhancement and sustenance of quality in education with a goal to achieve excellence in all spheres of life.

The foremost aim of the Institution is to create an atmosphere perfectly conducive to learning and true enlightenment.

Our Institution earnestly endeavours not only towards enlightening the pupil but also for their holistic improvement in to responsible citizens and exemplary human beings.

Our teachers try their level best to develop a friendly rapport and healthy camaraderie with the taught which is essential for a true academic environment.



They are highly accommodative and help the students to the best of their capability even beyond the usual college schedule.

The authority and the teachers seriously work towards the maintenance of an atmosphere that inspires and enforce strict discipline and decorum among the students.

6.1.1: Vision:

To spread knowledge and education through projects, research and distance education through correspondence course to the ground level.

6.1.4: ADDRESSING THE NEED OF THE SOCIETY

In our country one of the main objectives of higher education policies is to increase the access to higher education. Till Xth plan period only 8-9% of our youth in the age group of 18-24 years can get the opportunity of higher education, whereas in any country of medium development 20% of their youth of the same age group can have the opportunity of higher education and in the developed countries this figure is above 70%. There is a positive correlation between the percentage of population achieved higher education and economic development. Our national policy framers had an intention to raise this Gross Enrolment Ratio (GER) up to 25% without compromising the quality and the target was to attain



from 20.2% in 2011-2012 to 30.80% during XIIth plan period. The ratio in our Institution is a satisfactory one.

In our Institution 7806 students are getting quality education in different streams during 2013-2014 session compared to 6449 students during 2012-2013 session, 21% rise from the last year, which is a positive sign in the area where more than 50% families live below poverty line. After recording an increasing trend of enrolment for these couple of years the session 2014-2015 saw a slight fall in enrolment. Foundation of two more colleges within 10 k.m. radius of our college and social conditions can be held responsible for this fall. But it is to be noted that the enrolment of female students is increasing. The statistics is provided under student enrolment.

6.2: COLLEGE MANAGEMENT

Our college, as a Govt. aided college was running under the first Statute of the University of Calcutta approved by West Bengal State Legislation Act, 1979 till 2008. Presently, it is affiliated to West Bengal State University, the newly formed University, as per the State Assembly resolution 2008. The Statute of the newly formed university has been published in the month of May 2014 and has been enforced in to action w.e.f. 20th Nov 2014 by the order of Honourable Governor of West Bengal.

Top Management in Government aided College structure refers to the Governing Body, which is constituted with President, elected by the members of GB, Principal/TIC, two University nominees, two DPI nominees(as per the new Statute of WBSU there will be three nominees both from University and DPI) four elected members from teaching constituency, two elected members from non-teaching constituency, General Secretary of Students' Union and eminent personalities of local Government. GB in its meeting makes different resolutions for different developmental and Quality assurance programmes and activities to be carried out in the Institution. Principal/TIC as Ex-officio Secretary takes the leadership to ensure the effective execution of those resolutions.

6.2.1: FUNCTIONS OF GB:

With a view of proper planning and execution of different policies, GB is responsible for the following activities:

- ❖ To review the results of different examinations conducted by colleges and Universities and suggest measures for development. Simultaneously felicitates the meritorious students.
- ❖ Appoints Principal/TIC, teachers and other staff members on the recommendation of different appointing agencies of Govt. of WB.
- ❖ Ensure the laboratory and other infrastructural facilities available are adequate for carrying out academic works .
- ❖ Ensure the college building is properly maintained.



- ❖ Make sure the library is properly equipped with modern facilities.
- ❖ Make sure the teacher-taught ratio is satisfactory.
- ❖ Suggest and make efforts for providing quality in education.
- ❖ Make efforts to make our students socially committed and survive the global changes.
- ❖ Make sure that the existing depts. are equipped with modern facilities.
- ❖ Recruits casual staff and Guest lecturers for smooth functioning of the Institution.
- ❖ Takes steps to fillup vacant teaching and non teaching posts sanctioned by the Govt.
- ❖ Look after the interest of all concerned.
- ❖ Encourages teachers for their academic development through participation in FDP,RCs, Ops, Workshops, seminars, conferences and any other trainings organized by UGC and other related agencies.

6.2.2: ACHIEVEMENTS OF GB IN LAST FOUR YEARS

In last four years GB has taken a lot of measures for the alround development of the college.



- a. Constructed a separate building for administrative and official works out of college fund. Thus, we have now two separate sections; one is academic building and the other one is administrative building.
- b. Repaired and renovated Zoology ,Physics and Geography lab with latest equipments out of college fund.
- c. Repaired and renovated Mathematics and Computer science lab out of UGC fund.
- d. Constructed students' union room outside the academic campus.
- e. Constructed gardens in front of the administrative building.
- f. Created a post of Academic-in-Charge to look after the academic activities of the Institution, a unique step in this direction.
- g. Following proper procedure recruited 21 casual staffs to minimize and bear the heavy workload of office since our office is facing a stiff staff crunch. Group –C post is yet to be sanctioned by the Govt.

Meetings of these Sub-Committees are frequently convened by the conveners and proposals and resolutions are placed before Principal/TIC for execution and with the approval of GB these are executed following proper procedure.

Principal/TIC as CEO takes the leadership to ensure the proper execution of those activities with the help of the Sub-Committees.



Our Academic departments are divided in to 17 units and each department runs under the direct supervision of a senior most faculty member of the concerned department.

Office work is monitored by the Head clerk who heads the office.

In case of purchase procedure we maintain a decentralized mechanism of purchase. Different departments place their demands properly before Purchase & Repair Sub-Committee. Getting approval from the Finance Sub-Committee and subsequently from GB Purchase& Repair Sub-Committee recommend the direct purchase of articles up to the limit of 10,000.00 and go for tender process for the purchase valuing above 10,000.00.Any urgent demand of the department met from the contingency grant of Rs5000.00 per annum.

6.2.3.1: Admission Sub-Committee

Admission Sub-Committee looks after the admission process of the college. After the publication of H.S result Admission Sub-Committee meets to finalize the plan and procedure of admission for the session. Candidates after purchasing admission forms either from college counter or downloading from college Website apply for different courses they intend to be admitted. Then after scrutinizing the forms faculty members prepare the merit lists and place them before admission Sub-Committee for publication on college Web site or college notice board. After the publication



of merit list admission is being made through open counseling. Our college will go for **On line** admission process from the academic session 2015-2016.

6.2.3.2: Building & Development Sub-Committee

Building & Development Sub-Committee put proposals for infrastructural developments, enhancement of built up area, repair , renovation & proper sanitation of existing building. It also supervises the developmental works carried out in the campus.

6.2.3.3: Library Sub-Committee

Library Sub-Committee looks after the library works and assists librarian to carry out developmental works in library.

6.2.3.4: PF Sub- Committee

PF Sub- Committee monitor and supervises PF account of our employees and suggests measures for better management of the same.

6.2.3.5: Leave & Service book Sub-Committee

Leave & Service book Sub-Committee keeps the records of leaves taken by the staff, incorporates those in the service books of respective employees and finally put before GB through Principal/TIC for final approval.



6.2.3.6: Research & Academic Development Sub-Committee

Research & Academic Development Sub-Committee meets time to time to get stock of the research and academic related works by the faculty members and put them before GB for approval through Principal/TIC. Getting approval from GB it encourages teacher members for FDP funded by UGC. During this period 2 teachers are awarded Ph.D degree participating in FDP and one teacher submitted Ph.D thesis.

Since our college is a brain child of Bibhuti Bhusan Bandyopadhyaya, Rakhal Das Bandyopadhyaya and Dinabandhu Mitra, the cultural heritage of this institution is outstanding. Different cultural programmes are organised in our college round the year. Such programmes along with different seminars ,sponsored by UGC and other different agencies are organized under the supervision and suggestion of Cultural, Seminar& Publication Sub-Committee. This Sub-Committee also supervise the publication of college Magazine, college prospectus etc.

Our Academic Sub-Committee, comprises of all senior most faculty members, suggests different measures to be adopted for a healthy academic atmosphere and sustenance of quality in education. This Sub-Committee also takes initiatives to effective



implementation of course curricula designed by our affiliating University.

Students are the vital part of an educational Institution. Thus, apart from imparting teachings to them their welfare has been given top most priority by our Management. Keeping this in mind GB has formed a Sub-Committee, called Students' Welfare Sub-Committee. Any student related problem brought to the notice of this Sub-Committee and the recommendations executed by the Principal/TIC after getting approval from GB.

6.3.2.7: Examination Sub-Committee

Examination Sub-Committee prepares plans and procedures for holding college examinations and brings them to the notice of AIC and Principal/TIC for execution. It also make necessary arrangements for smooth conduct of different University Examinations.

The Right to Information Act, 2005 is one of the most important legislation of the Government of India to promote transparency and accountability in the functioning of the Government. Yes, we have not forgotten this endeavor of the Government. To achieve transparency in our day to day functioning GB of our college has established **RTI cell** in our college. It is duty is to reveal all unclassified information related to college administration as and when required by an ordinary citizen of the society.



6.3.2.8: Grievance Redressal Cell

There is a Grievance Redressal Cell comprising the members both from teaching non-teaching category to suggest measures to prevent and minimize grievances of all stake holders. Receiving reports on grievances of any stake holder of the college convener of this cell convenes meeting of the cell under the Chairmanship of Principal/TIC. In the meeting steps are discussed in full to redress and minimize the grievances and put a break on its further occurrence. Then the suggestion is forwarded to concerned department/authority for proper execution.

Our GB has developed a Women Cell to deal with the Women related problems faced by our female students, female teachers and female staff. The steps suggested by the Cell are implemented properly with the approval of GB.

Besides this, on the suggestion of TC and IQAC Principal/TIC has formed a Placement Cell for better employability of students since 2007. It makes contacts with different agencies and arranges campusing for students.

6.2.3.9: IQAC

IQAC, one of the consulting bodies to Principal/TIC, formed on the recommendation of NAAC peer team on 3rd January ,2005.



❖ COMPOSITION OF IQAC

IQAC consists of the following 8 members.

- a. Principal/TIC as chairperson
- b. Faculty-6(one of the senior member acts as Co-ordinator)
- c. Librarian-1(Co-opt)

This Cell acts as a body for enhancement and sustenance of quality in education. It provides consultation to Management and guides Principal/TIC in implementation of different quality assurance programmes in the Institution. It also plays the role of monitoring and supervising the measures suggested by it for execution. Different quality assurance steps discussed in the meeting of IQAC and put forward before GB through Principal/TIC in the form of proposals for approval.

It also monitors and keeps records the academic and administrative performance of teaches and recommends their career advancement to GB for approval and subsequently to DPI for fixation of enhanced scale.



6.2.3.10: HUMAN RESOURCE MANAGEMENT

To maintain a healthy student–teacher ratio GB always takes positive and constructive steps in this direction. Due to inadequacy of Govt. sanctioned teaching and non-teaching posts and delay in process of appointment GB takes initiatives to appoint Guest Teachers and casual non teaching staff for smooth running of the Institution. To appoint Guest faculties on recommendations the college invites applications through advertisements in the leading newspapers of both Bengali and English versions from the persons having requisite qualifications as per UGC norms. The Selection Committee is formed with a subject expert from the affiliating university, Head/Senior most member of the concerned department, of the college and Principal/TIC. The Selection Committee calls short listed candidates for the interview and prepares a panel taking the scores of interview and academic performances together into consideration. Then the panel is placed before GB for approval and Principal/TIC, as CEO issues appointment letters according to the merit panel.

In case of Non teaching category appoint Management follows same procedure .The Selection Committee formed for non teaching category appointment comprises of President of the GB, Principal/TIC of the college, a DPI nominee, a University nominee, a teacher nominee.(All are the members of GB.)



Staff, both teaching and non teaching, appointed by Management are paid from college exchequer. Nine teaching staff, appointed by Management, are getting salary from Government exchequer as PTT and their service tenure has been extended till their the age of sixty years.

6.2.3.11:Welfare schemes for Faculty and Staff

- i. Rent free accommodation for the Hostel Superintendent.
- ii. Facility of loans at concessional rate of interest from Staff Co-operative Society.
- iii. Ad-hoc payment of salary in the months of non receipt of pay packet.
- iv. Admission reservation to any course for the children and the wards of the Employees.
- v. Canteen, recreation and physical fitness (use of Gym) facilities.
- vi. Free use of college infrastructure for individual research.
- Vii. Ex-gratia payment during festival like Durgapuja .Viii. Festival bonus to Management appointed teaching and non-teaching staff during Durgapuja.
- ix. Day care facility for wards of staff.
- X. Purified and Cold water supply for teachers, non-teaching staff and students.

Xi. Loan from college fund without any interest to staff for medical treatment and marriage ceremonies of their wards, if demanded.

6.2.3.12: Inspiration and assistance for both teaching and non-teaching staff.

- ❖ Teachers are encouraged and inspired to participate in RC, OP and FDP from time to time. It also helps them in their career advancement.
- ❖ They are also inspired to attend and participate seminars, symposiums, conferences, workshops etc in state, national and International level to apprise their academic activities.
- ❖ Departments are inspired to get grants from different funding agencies such as UGC, State and Central Governments for holding seminars on state, national and International level. Sometimes college encourages for such seminars from college fund.
- ❖ Teachers are inspired to carry out research works abroad. Till the date two have done their post doctoral researches abroad.
- ❖ Sometimes college organizes different programmes on burning current issues such as thalassaemia, atrocities on females, chit fund etc to bring about awareness among the staff and to enrich them with current happenings.
- ❖ Training programmes are carried out round the year for accounts department, office & library staff.



- ❖ Computer awareness training programmes are held to increase the level of computer knowledge of the non-teaching staff.
- ❖ Arrangement of annual picnic, vijayasammilani and other social programmes to increase the confidence and the level of understanding among the staff members.
- ❖ Acknowledgement and appreciation of any special achievements of staff members in their respective fields.
- ❖ Arrangement of welcome ceremonies on joining and farewell on retirement.

6.3: PRINCIPAL/TIC

The Principal is directly responsible and accountable to the GB of the College for the effective leadership and the overall management of the College. The Principal represents the GB on a day-to-day basis. The Principal's mission is to enhance the standards of education by providing an outstanding, creative, participative, learning environment that is consistent with the core values of higher education. The Principal is primarily assisted in the administration of the College by three statutory bodies of college such as TC, IQAC and FINANCE SUB-COMMITTEE. Other sub-committees are also there to assist in execution of different policy matters ,plans and activities approved and framed by GB.



• Key Tasks

The Principal is directly responsible for the following key tasks:

- provision of full information to the GB on all issues pertaining to the College;
- implementation of its overall policies and provision of advice to the GB on policy matters and forward planning;
- direction, conduct, management, organization and tone of the College and for the overall supervision of all College activities;
- appointment, attention, professional development and sustenance of quality in education;
- management and supervision of the College finances and maintenance of college Financial audit with the help and assistance from Finance sub-committee and Bursar;
- exercise of a leadership role in managing relationships and building a collective group;
- provision of educational leadership, planning, implementation and monitoring of the academic curricular and co-curricular programmes;
- academic, personal and social development of students, and their enrolment ;



- active participation in appropriate professional educational organizations; and maintenance of a co-operative and supportive atmosphere within the College community and between the College and the broader community.
- management and development of the culture conducive to education, where learning is paramount, and all individuals are encouraged, respected and challenged intellectually, physically and socially
- maintenance of an understanding of evolving trends in education, keeping abreast of school leadership and curriculum development issues and participating in principal development activities.
- To determine, in conjunction with the GB, the aims and objectives of the College.
- Periodic review of performance of staff, both teaching and non-teaching, for guidance and improvement through physical verification, discussions in the meetings.
- Ensuring the commitment and accountability of all teaching and non –teaching staff.
- Allotment of individual responsibilities and duties.
- Ensuring the care and maintenance of records.
- Functioning as DDO(drawing and disbursing officer) as per the guidelines of Govt. of WB.



- Preparation of effective budget ,mobilization and utilization of resources.
- Promotion of welfare schemes for all stakeholders.
- Ensuring the career advancement of staff, both teaching and non-teaching.
- Presiding over the meetings of all Sub-Committees to monitor the execution the different measures assigned to respective Sub-Committees.

6.4: TEACHING AND LEARNING

The Management along with Principal/TIC as CEO leaves no stone unturned for effective and efficient execution and supervision of teaching learning processes in the Institution. For proper supervision and monitoring of the process our Management has undertaken a unique and fruit full step by appointing a senior and sincere faculty as Academic-in-Charge of the college.

Since teaching learning process starts primarily with admission process at the commencement of each academic session Principal/TIC took the leading role along with the admission sub-committee to make sure the implementation of transparent and impartiality based admission procedures framed by affiliating university, Government and the GB by strict vigilance over day to day admission activities. During this period admission sub-committee play a vital role.



GB has introduced different subjects such as Geography, Education, Computer Science in last couple of years and planned to introduce Sociology, Physical education and Psychology in near future after getting proper approval from relevant bodies.

Management has introduced semester system of examination in Bengali PG course.

Management has installed the mechanism to provide modern teaching aids by development of digital class room, extended Internet facility ,INFLIBNET ,Net working, OHP, Laptop, LCD projectors etc The Management has planned and decided to extend the benefits of Information & Communication Technologies and MIS in coming years.

Academic counseling and remedial coaching are provided to slow learners of the college round the year.

Test examinations are held regularly and students are evaluated and suggested for improvements.

Efforts are being taken to modernize our central library. Vacancy of the post of librarians since last 10 years was putting hindrances on the way for upgradation and modernization of library. Now the joining of two librarians will help us to achieve our goal of modernizing the same. Our central library has been partly computerized and steps are being taken to make it fully computerized in near future.



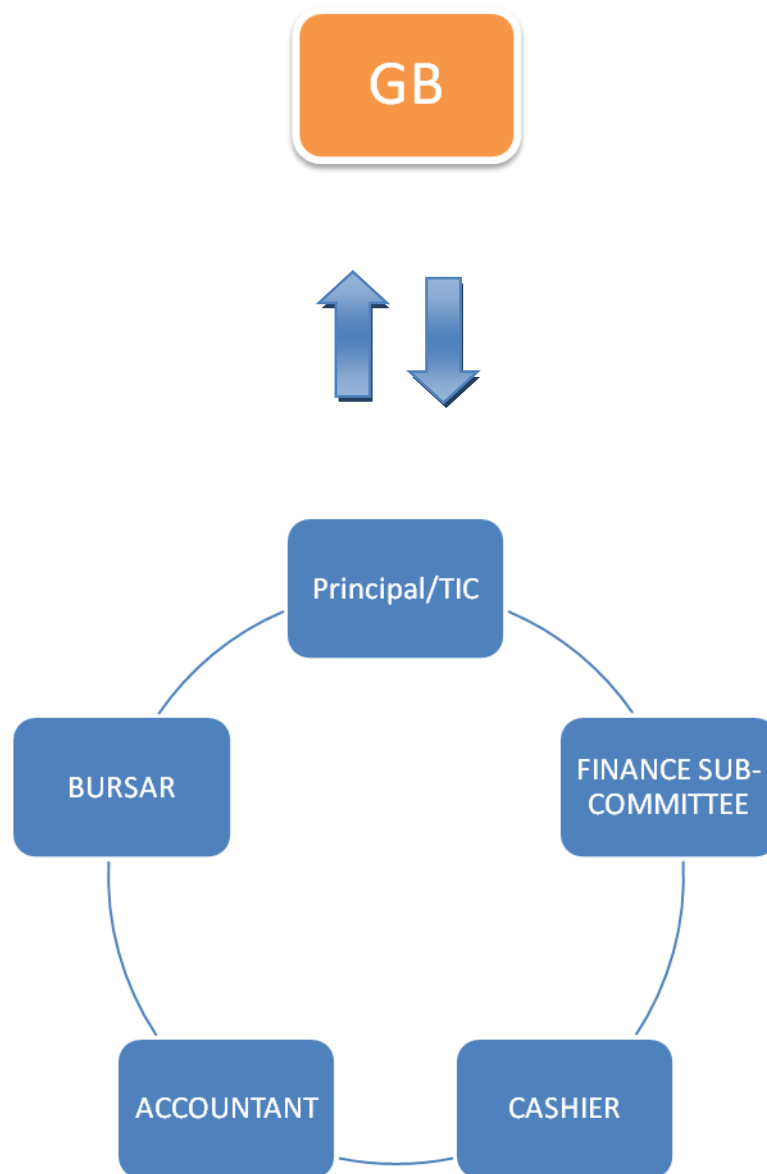
To increase the access of students Management takes initiative in allotting funds in addition to the UGC funding to purchase books and journals for the central library and departmental libraries and to buy equipments for the laboratories to meet their increasing demands.

Parent teacher Association and Alumnae are two important and guiding bodies in our teaching learning processes. Observations, support and suggestions forwarded by these bodies evaluated and implemented as per their merit.

6.5: WASTE MANAGEMENT AND ECO-FRIENDLY ATMOSPHERE

The Management gives utmost importance to waste management and always tries to provide an eco-friendly atmosphere. College NSS unit plays a leading role in this direction.To provide eco-friendly atmosphere our college has installed solar light system and smoke free generator(Kirloskar).We have developed a fruit orchard in the back side of our college and flower gardens both in front of the administrative building and inside the old building campus.

6.6: FINANCIAL MANAGEMENT AND RESOURCE MOBILISATION





The above diagram shows how the finance of our college is being managed. Cash section and Accounts deptt. headed by Accountant work under the supervision and guidance of the Finance Sub-Committee , Bursar and executive control of the Principal/TIC, who is answerable to GB. The main objectives of Financial Management are as mentioned below:

❖ Objectives

- To ensure that the college's operating revenue is deployed in ways which best realize the college's objectives, approved plans and academic purposes;
- To ensure that academic and administrative units have the resources required to carry out their work effectively,
- To provide an effective means of monitoring revenue and controlling expenditures in conformity with the highest standards of financial management and accounting.
- To keep and protect the records of financial transaction and auditing.

Accounts department undertakes all works related to accounting including treasury and bank operations and preparation of annual draft budget of the college with consultation and supervision of Bursar and Finance Sub-Committee. Draft budget is prepared at the end of each financial year, taking into consideration the

financial requirements of each departments and the general development plans designed by building and development Sub-Committee. After getting sanction from the Principal/TIC the draft budget finally submitted to the GB for approval. Then the budgetary allocations are made available for implementation following relevant financial rules and regulations. Our expenditure is divided mainly in two parts: a)Salary related Expenses b)Other expenses. There are also sub parts.

6.6.1: Salary Related Expenses

- Payment of salary to staff, both teaching and non-teaching appointed on Govt. sanctioned posts.
- Retirements of staff
- New hires and appointments by Management
- Staff benefits
- Provision for salary hike for management appointed staff, both teaching and non-teaching.
- Research activities

6.6.2: Other Expenses

- General expenses
- Repair and renovation expenses
- Equipment needs
- Maintenance contracts
- Computer software needs
- Supplies
- Stationery

While preparing draft budget weight age is given to the following items:

- infrastructural development
- research activities
- repair and maintenance
- student welfare
- sports
- library
- staff welfare
- enhancement of better academic atmosphere
- holding of seminars, conferences, workshops etc



The Principal/TIC as Drawing and Disbursing Officer(DDO) receives grants and presents financial reports to different funding agencies such as State Government, UGC etc time to time.

6.6.3: PAYMENT PROCEDURE

- Bills submitted in receiving section and numbered → then it is submitted to the office of accountant for record and verification → to Bursar for verification and approval → finally to Principal/TIC for approval.

Payments are made either in the form of cheque or DD. Small payments are made in cash.

6.6.4: Institutional mechanism for auditing

The Finance and accounts operation of the college are regularly audited by the auditors deputed by the Director of Public Instruction, Government of West Bengal as statutory audit. Audit till the financial year 2010-2011 has been completed and the audit for the next financial year is on process.

We have installed a software for computerization of our accounts department. From next session we will be able to have a fully computerized accounts section.

6.6.5: RESOURCE MOBILISATION

Our main source of income is the fees collected from our students, grants received from State Govt. and UGC. Sometimes we also receive funds from MPLAD and from our local MLA.

Since more than 90% of our students are from SC,ST and Backward communities and more than 30% students are 1st generation learners we have had a very moderate fee structure in our college. But to meet an inflated capital cost ,revenue cost and establishment cost we are forced to make a nominal hike in fee our structure in GB meeting dated 07.06.2013 agenda no-12. Still it is moderate after the hike in comparison to the other colleges of our State, even the colleges situated in 20 k.m. radius of our college. Our fee structure is as follows:

Science students from Honours stream pay laboratory fees of Rs 500 and pass students pay Rs 200. Students with Geography as combination pay Rs 600 as lab fees and students of Mathematics Honours pay Rs 400 as lab fees.

Since Geography has been introduced as self financed course students of Geography Honours pay Rs 400 as admission charge, Rs 6000 as establishment charge and Rs 400 as monthly tuition fees.

Criterion 7: INNOVATIVE PRACTICES

7.1: WOMEN'S CELL:

The principle of gender equality is enshrined in the Indian Constitution in its Preamble, Fundamental Rights, Fundamental Duties and Directive Principles. The Constitution not only grants equality to women, but also empowers the State to adopt measures of positive discrimination in favour of women.

Within the framework of a democratic polity, our laws, development policies, plans and programmes have aimed at women's advancement in different spheres. From the Fifth Five Year Plan (1974-78) onwards has been a marked shift in the approach to women's issues from welfare to development. In recent years, the empowerment of women has been recognized as the central issue in determining the status of women. The National Commission for Women was set up by an Act of Parliament in 1990 to safeguard the rights and legal entitlements of women. The 73rd and 74th Amendments (1993) to the Constitution of India have provided for reservation of seats in the local bodies of Panchayats and Municipalities for women, laying a strong foundation for their participation in decision making at the local levels.



However, there still exists a wide gap between the goals enunciated in the Constitution, legislation, policies, plans, programmes, and related mechanisms on the one hand and the situational reality of the status of women in India, on the other. This has been analyzed extensively in the Report of the Committee on the Status of Women in India, "Towards Equality", 1974 and highlighted in the National Perspective Plan for Women 1988-2000, the and the Shram-Shakti Report 1988.

With the aim of fostering gender-sensitivity and effectively meeting the problems of female-students, our college had instituted a 'WOMEN-CELL' in 2009. The cell seeks to create awareness among the female-students regarding their overall development through organizing seminars, holding discussions, exhibiting their paintings and their crafts. The cell also seeks to raise awareness towards pressing social issues through signature campaigns. A wall magazine has been introduced by the forum by the female students of our college who eagerly participate in the programmes of the cell.

The motto is to, encourage the female students to gain knowledge and skills that will help them to overcome the obstacles in their life and work situations and ultimately develop themselves in society. Through nurturing skills for self-sufficiency, the cell seeks to eliminate the future need for charity.



To infuse sensitivity and raise their consciousness, the women cell annually celebrates the '*International Womens' Day*' on 8th March. The occasion is marked by seminars, open discussions and highlighting the skills and talents of the female students as painting, crafts-making and elocution.

A few small strides taken in this direction are as follows;

A seminar was organized on 8th March 2009 to celebrate the '*International Womens' Day*' and the occasion was graced by Prof. Bonita Aleaz (ex-head), department of Political Science, University of Calcutta. She delivered a lecture on the topic '*Patriarchy: Different Views*'.

A Signature Campaign was organized by the Women Cell in 2010 to create awareness on women rights. The theme of the campaign was '*International Day for the Elimination of Violence against Women*'.

The chief guest in the annual celebration of *International Womens' Day* in the year 2011 was Prof. Basabi Chakraborty, Faculty Member, Department of Sociology, RabindraBharati University. The topic for discussion was '*Social Status of Women in India*'.

In 2012, an NGO from Dum Dum was roped in for an interactive session on the theme '*Save the Girl Child*'. The session included showing a documentary and open discussion on the theme.



7.2: TEACHING-LEARNING:

We sincerely believe that the best result with respect to student learning outcome results from active participation and interaction on the part of both the teachers and students. The teachers employing the best practices in teaching and learning engage the students actively in their studies amongst themselves as well as with the faculty members and implement regular and periodic assessment in order to evaluate how well their programme is in meeting the objectives.

Emphasis is laid upon;

- Engaging students in active learning experiences
- Setting high and meaningful expectations
- Receiving regular and specific feedback
- Creating awareness of social and moral values
- Recognizing student creativity and talent and encouraging those for their development
- Seeking and presenting real-world applications
- Understanding and valuing criteria and methods for student assessment
- Creating opportunities for student-faculty interactions
- Creating opportunities for student-student interactions
- Promoting student involvement through engaged time and quality effort

7.3: e-LEARNING:

Conceptually, e-learning is broadly synonymous with instructional technology, information and communication technology (ICT) in education, computer-based instruction (CBI), computer managed instruction, computer-based training, computer-assisted instruction or computer-aided instruction. They refer to the use of modern tools, such as computers, digital technology, media with interactive exercises that facilitate learning.

Bernard Luskin, an educational technology pioneer, advocating the concept referred to the "e" of e-learning to mean 'exciting, energetic, enthusiastic, emotional, extended, excellent, and educational' in addition to 'electronic'. The domain has been expanded that 'e' should refer to 'everything, everyone, engaging and easy.

Keeping with the modes of 'e-learning' a computer is used to deliver part of a lesson or course. The computer is often used to show maps, places of historical importance or important buildings both national and international. Instructions and demonstrations through computers allow each individual to take the topic at their own pace. Audio-visual helps the students in better understanding and retention of the subject matter.



The emphasis is upon 'blended learning', which is the use of e-learning alongside traditional face to face interaction and discussion to combine the benefits of both.

7.4: INTER-DISCIPLINARY TEACHING:

Increased emphasis on student assessment will lead to improvements in teaching and learning. To improve faculty teaching through direct faculty interaction (e.g., attending workshops, visiting each other's classes, creating teaching portfolios). This is particularly useful for younger faculty, who seem more preoccupied with research. It provides interaction with more experienced faculty mentors. Advocates a change in institutional structure that values and rewards teaching to greater degrees.

While emphasizing upon verbal skills, the aim is to situate academic knowledge with real world situations. While delving upon active faculty learning the faculty members listen to students and try to develop understanding, identify gaps in knowledge and clarify what they have just learned.

The aim is to promote academic success by emphasizing student-student, faculty-student interaction and interdisciplinary course linkages. Classes focus on improving the quality of learning and not just content or outcomes.



Learnings promote change in cultures, the emphasis is on developing collaboration between academic affairs and student affairs, and among faculty in terms of sharing knowledge about teaching.

Apart from introducing innovative practices in the academic field, we have taken small steps in providing a better environment. For protecting our immediate environment around the college, we have developed,

7.5: PLASTIC-FREE ZONE:

Plastics around us have proved to be a menace, therefore to make life healthier and better, we need to negate its poisonous effects on our natural environment.

It's unlikely that any of us will be able to completely eliminate our exposure to plastic, as we run into them every time we leave our house, but we can make wise choices about the items we use.

Keeping this in mind, we have decided to declare our college campus as 'plastic-free zone'. The students as well as staff members are discouraged from using plastic in any form within the college campus.

We could all do with a little less plastic in our lives, and eliminating even a third of the items we have in our homes can improve our health and well-being.



7.6: GREEN BELT:

Keeping the issue of environmental protection in mind, developing a green belt within the college campus is one priority area. As a result, saplings are planted at regular intervals in the open ground within the college campus to provide greenery and fresh air.
